 - 5. The existing fire alarm panels are Bosch.
 - 6. All condensing units shall be 36" minimum away from the building.
 - 7. The condensing units at building 132/137 and 136 latrine area shall be relocated per dwg M-102 Rev-1, M-103 Rev-1, and M-300 Rev-1, see attached.
