

## ADVERTISEMENT FOR BIDS

Sealed bids for **DEARNG Contract No. 2018-001 – Georgetown Readiness Center – Natural Gas Conversion & Emergency Generator**, will be received by the Delaware Army National Guard at the Security Officers desk in the Main Lobby of the Biden National Guard/Reserve Center, 250 Airport Road, New Castle, Delaware, 19720 until **2:00 PM local time on May 17, 2018**, at which time they will be publicly opened and read aloud in the Multi-Purpose Room.

Bidders are required to show identification at the Guard Booth when entering the site and must sign in at the Security Officers desk once inside. Please allow sufficient time to comply with these requirements. No exceptions. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the installation of a new natural gas service from Chesapeake Utilities and the conversion of the site primary fuel source from #2 fuel and propane to Natural Gas, and the installation of a new 100kW emergency generator and Automatic Transfer Switch at the Georgetown Readiness Center.

Attention is called to the construction schedule as detailed in the Contract Documents.

A **MANDATORY** Pre-Bid Meeting will be held on **May 1, 2018 at 11:00 AM** at the Georgetown Readiness Center, 109 W. Pine St., Georgetown DE 19947, for the purpose of establishing the listing of subcontractors and to answer questions. You will be required to show identification at the Guard Booth when entering this site. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Sealed bids shall be addressed to the Biden National Guard/Reserve Center, 250 Airport Road, New Castle, Delaware, 19720, ATTN: 2LT Brittney M. Poore. The outer envelope should clearly indicate: **DEARNG CONTRACT NO. 2018-001 Georgetown Readiness Center – Natural Gas Conversion & Emergency Generator - SEALED BID – DO NOT OPEN.**

Minority Business Enterprises (MBE), Disadvantaged Business Enterprises (DBE), Women-Owned Business Enterprises (WBE) and Veteran-Owned Business Enterprises (VBE) will be afforded full opportunity to submit bids on this contract and will not be subject to discrimination on the basis of race, color, national origin or sex in consideration of this award.

Each bid must be accompanied by a bid security equivalent to ten percent of the bid amount and all additive alternates. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informalities therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days' notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
