Sealed bids for **DEARNG Contract No. 08-2014- River Road Training Site – Building 1 Demolition**, will be received by the Delaware Army National Guard at the Security Officers desk located in the Main Lobby of the Biden National Guard/Reserve Center, 1 Vavala Way, New Castle, Delaware, 19720 until **1100 AM** local time on **Tuesday September 24, 2019**, at which time they will be publically opened and read aloud in the Multi-Purpose room.

No exceptions. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

This project involves general demolition of existing structure and all associated work for DEARNG Building 1 River Road Training Site.
