Sealed bids for **DEARNG Contract No. 02-2014 – Delaware Army National Guard (DEARNG) Scannell Readiness Center Paving Improvements**, will be received by the Delaware Army National Guard at the Security Officers desk located in the Main Lobby of the Armed Forces Reserve Center located at 250 Airport Road, New Castle, Delaware, 19720-1502, until **10:00 AM local time on Tuesday, August 4, 2015**, at which time they will be publicly opened and read aloud in the Multipurpose Room located next to the main lobby. Project will take place at the **DEARNG Scannell Readiness Center** located on the Governor Bacon Complex, Delaware City, DE 19706, involves asphalt parking lot rehabilitation paving, concrete work, drainage improvements, site grading, new asphalt parking lot construction, electrical lighting, fencing and gates.

Dates and times for the site visits will be established during pre-bid meeting in order to provide opportunities to contractors / subcontractors to complete measurements, take pictures, etc. as the facilities are not open to the public. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract.
