Work for materials not specifically mentioned herein are to be described in the main body of the specifications and as shown on the drawings. Bidders shall acknowledge receipt of this addendum on the space provided on the Bid Form. Failure to do so may subject the bidder to disqualification.

GENERAL CLARIFICATIONS:

1. Nothing to Report.

QUESTIONS AND ANSWERS:

- 286. Contract D-24 Note 25, requires to provide entrance matts and frames. There are no specifications. Also note is not found in technical specification section in D-24 Scope of work.
 - a. There are no entrance mats or frames included in this project. Walk-off carpet at the entrances is to be provided by Contract D-32: Carpet & VCT.
- 287. Please see attached cut sheets for our line of Acoustech Wall/Ceiling products as manufactured by AVL Systems Inc. We would like to be approved as an equal for the products in spec section 098400 Acoustic Room Companents for the Appoquinimink School District Fairview Campus New Middle and High Schools Bid Pack C. Please see the attached Substitution Request along with Comparrison Sheet and Data Pages as requested.. Please feel free to contact me with any questions or if you require additional information to approve the request.
 - a. AVL has been added as acceptable manufacturer. See Addendum No 8.
- 288. Please see attached submittal package for our firestop products requesting to be added as an acceptable product to your specifications. My contact information is below should you have any questions. Our product line is fully tested and listed by UL, FM and Intertek to UL1479, ASTM E-814 and ASTM E2307 including a 3Hr test using 100% vision glass curtain wall.
 - a. Approved Substitution. See Addendum No 8.
- 289. Campbell Rhea our science casework supplier, the one supplied on all your jobs is not listed. Can they be added as an approved manufacturer?
 - a. Yes, See Addendum No 7.
- 290. I need to know the model number, voltage and phase of kiln needed. This is not listed. 240V or 208V? Phase: 1 or 3? Model: KW1-1027 is not a good number, do they want a KM1027 kiln?
 - a. See Addendum No 8.
- 291. Detail G8/A492 shows a wood bench at stairways while A3/A351 shows solid surface bench top. Advise which material is to be used.
 - a. Solid Surface to match typical window sill
- 292. Contract D-24, requires to provide exterior PVC railing, specifications are needed.
 - a. PVC Railing detailed on sheet A-504 is the same product referenced in Specification section 062000

- 293. Contract D-24 requires for Commercial Laundry Equipment. The dryers are only called out in the specifications. How many are required? please confirm there are no other appliances needed.
 - a. One (1) commercial washer and (1) commercial dryer See E7/A423.
- 294. Contract D-24 requires for Wheelchair Lift, please confirm there is only one Wheelchair Lift. Please advise.
 - a. Confirmed Only one wheelchair lift
- 295. Contract D-24, Note 6, requires PVC Railing, PVC is not noted in the technical specs. Specifications are needed.
 - a. PVC Railing detailed on sheet A-504 is the same product referenced in Specification section 062000
- 296. When drawings were reissued for Addendum #4 the floor plan wall type markings were deleted on some of the plans. See A116 for reference. Also, please review the locations of sound walls as I would assume that all principal offices, conference rooms and SRO offices should be sound rated at all walls, some are shown as non-insulated between file rooms and those sensitive areas. While it is not a huge cost item, it would save the hassle of COR later to correctly isolate sensitive areas such as toilet rooms, and other sensitive offices.
 - a. Refer to enlarged plans for each area for partition tags.
- 297. Please provide sheet where Room B202a elevations can be found. I'm assuming F3 is to be on A407. B6 doesn't match what is shown on A407. Where can this elevation be found?
 - a. See D5 and D7 on A407
- 298. PAGE 18-ITEM dd -REFERS TO A-405 DETAIL A1. THAT DETAILS DOES NOT EXIST ON THE PLAN I HAVE, IS WAS NOT REISSUED IN ANY PREVIOUS ADDENDUM AS FAR AS I CAN SEE, PLEASE CONFIRM THE REFERENCE AND OR REISSUE THE PAGE.
 - a. Item dd on Page 18 refers to A-404
- 299. DETAIL A6- ADDED VP6 NOTE ADDED- THE NEW VISION PANELS ADDED ARE NOT LOCATED ON WALLS- WE ASSUMED WALL BETWEEN COTS AND OFFICE.

- a. Correct
- 300. Drawing G-121 clearly separates Bid Packages C & D. But, because the carpentry contract's scope of work is for ALL buildings then our bid is for work relating to both packages C & D. Could you please confirm that this is correct?
 - a. Correct. Work included in Contract D-24: Carpentry & General Works applies to all areas of the building (Areas A through H).
- 301. Regarding the Operable Partition in "Business C130/131". I noticed in the spec that it is calling for marker boards on the faces of the panels, but it doesn't specify the quantity, size, or location. I've looked through the drawings and the addenda, but I haven't seen any drawings to provide this information. Will you be adding a drawing for that information?
 - a. Both sides all markerboard floor to ceiling.
- 302. Referencing Detail 11/A-005: Reference is made to acoustical doors. Which doors or vision panels does this typical detail apply to?
 - a. All details on Sheet A-005 apply to rooms tagged 'AT' on floor plans.
- 303. Referencing Detail 11/A-005: I'm not sure if there are any doors of type E because I don't see any on the door schedule. There are type EE.
 - a. Delete reference to Door Type E in detail 11/A005.
- 304. Provide elevations E7 & E8/A403.
 - a. E7 & E8 / A-403 have been provided. Will be issued in Addendum no 9.
- 305. There is un-elevated casework in room D119. Item #195 of ADD #6 identified an elevation that was already provided.
 - a. F8/ A-408 added, will be issued in Addendum 9.
- 306. Item #195, ADD #6 Description of E8/A401 in room D119 & B9/A406 in room D121 are wrong.
 - a. For D119 See E8/A-401 & F8/A-408. For D121 See H7/A408
- 307. Is there any casework intended beyond elevation D1/A401 in room B107?
 - a. Yes. See D8/A406
- 308. Elevate the work at the angled wall in room B102O.

- a. See sketch A-776 in addendum 8
- 309. Item #203 in ADD #6 is incorrect. Provide correct elevation.
 - a. See D1 and D2 on A403
- 310. Provide elevation for casework OUTSIDE of room A242. ADD #6 provided elevations that are already called out.
 - a. No casework is required at this location.
- 311. Regarding the wall mounted hooks: Elevations H3/A-407 and E3 & D3/A-408 have a call out for them but none are depicted in the elevation drawing.
 - a. Hooks are depicted on H3/A-407 and E3 & D3/A408
- 312. The carpentry scope includes GFRC decorative columns and cornices. The spec only mentions columns and so far I haven't found any GFRC cornices. Are there any?
 - a. There are No GFRC Cornices included in this project.
- 313. D1/A-364 refers to MS cupola. We'd just like to confirm that this is not a prefab cupola that is part of the carpentry package.
 - a. Confirmed- not a pre-fab cupola.
- 314. Scope for contract D-37 says we are to include all signage (interior and exterior) and plaques but I can not find anything on either
 - a. Signage is being purchased by the district at a later date. Contract D-37 does not provide signage. See changes to the specification included in this addendum.
- 315. Referring to this note on the floor plans: "Provide 8'-0" high, 3/4" fire-treated plywood panel backboards in all electrical and telecommunication rooms and closets as requried for installation of equipment. Paint prior to installation." We understand what an electrical room is and we would think the IDF rooms get the plywood but how about EMR rooms? The note seven is just a general note and doesn't appear at each location. Finally, we assume the plywood goes on all four walls of the rooms?
 - a. Plywood is for electrical rooms and MDF/IDF rooms only. Plywood is to be installed at all four walls of the rooms.
- 316. The summary of work for contract No. D-38: Gymnasium Equipment and Bleachers references Sections 100600 and 110600 which do not exist, it also does not detail all

- requirements included in Section 116625. Can this summary of work be updated to be more specific to the project?
- a. See changes to the specification included in this addendum.
- 317. The summary of work for contract No. D-41: Theatre Seating does not mention Section 126623, which is also add alternate 29. Can you confirm that Section 126623 and add alternate 29 are part of this scope?
 - a. Section 126623 and add alternate 29 are both part of the scope for Contract D-41: Theatre Seating. See changes to the specification included in this addendum.
- 318. Ref. specification section 011100 Summary of Work, Contract No. D-33 Ceramic Tile, Page 37, Item #2, Quarry Tile. The scope of work indicates to provide Quarry Tile however we find no quarry tile finished noted on the Finish schedule. Are quarry tile finishes required? If so, where?
 - a. Quarry tile finishes are not required in this project. See changes to the specifications included in this addendum.
- 319. Ref. specification section 011100 Summary of Work, Contract No. D-33 Ceramic Tile, Page 37, Item #9. We note the scope of work indicates the ceramic tile contractor is to provide cementitious backer units as part of the tile installation. Can the cementitious backer units be provided and installed as part of another contract?
 - a. Cementitious Backer units will be provided by Contract D-24: Carpentry & General Works. See changes to the specifications included in this addendum.
- 320. Ref. specification section 011100 Summary of Work, Contract No. D-33 Ceramic Tile, Page 38, Item #22. We note this contract is to provide BIM services. BIM services are not typically required for the ceramic tile contractor. Please confirm whether CAD file shop drawings will be acceptable in lieu of costly BIM services.
 - a. BIM services are not required of Contract D-33. Please refer to the Model Element Table included in Spec Section 013700 for specific requirements of BIM services from each contract.
- 321. Ref. specification section 011100 Summary of Work, Contract No. D-34 Terrazzo Tile, Page 40, Item #13. We note this contract is to provide BIM services. BIM services are not typically required for the ceramic tile contractor. Please confirm whether CAD file shop drawings will be acceptable in lieu of costly BIM services.

- a. BIM services are not required of Contract D-34. Please refer to the Model Element Table included in Spec Section 013700 for specific requirements of BIM services from each contract.
- 322. What contract owns the cementitious wood fiber panels (Tectum), for example E1/A-455?
 - a. Cementitious Wood Fiber Panels (Tectum) are to be provided by Contract D-30 : Acoustical Ceilings and Wall Panels.
- 323. In ABHA's addendum 7 under finish carpentry on page 2, it adds "mount hooks on a continuous ledger board: $\frac{3}{4}$ inch x 7 $\frac{1}{4}$ " poplar, opaque (paint) finish. Will this board be furnished by the casework and millwork contract?
 - a. Continuous ledger board for the mounting of hooks is to be provided by Contract D-24: Carpentry as part of the wall mounted hook installation.
- 324. Are the server/cafeteria Plam/Corian cash wraps included in our scope or the Kitchen equipment vendors?
 - a. See culinary equipment schedules included in the QF drawings for a listing of the casework and countertops provided as part of Contract C-16: Kitchen Equipment. Contract D-28: Casework is responsible to provide any casework and millwork in the kitchen and cafeteria areas not listed on the culinary equipment schedules.
- 325. Are all the wall mounted coat hooks provided and installed by others?
 - a. Wall mounted coat hooks are being provided by Contract D-24: Carpentry.
- 326. Please verify which contract provides and installs the Plastic Laminate Wall Panels shown on A-532.
 - a. Plastic Laminate wall panels are to be provided by Contract D-28: Casework and Millwork.
- 327. Alternate #28 indicates the gear package is to be the same manufacturer as specified in Appo Bid Pack "C" Addendum #7. We find no designation in Add# 7. Please provide clarification on specified gear manufacturer Being used on Appo Bid Package "C"
 - a. Please see updated Specification Section 012300 : Alternates included in this addendum.

- 328. Please confirm which contract provides the K-13 Spray acoustical insulation on the underside of the exposed decks? I remember you telling me we did not own it when I was bidding Bid Pac C, but I still cannot find it in any of the scopes of work. I thought the painter may have it, but I do not see it in there, so I just wanted to be clear that it is not in contracts 24, 25, 30 or 31.
 - a. Sprayed acoustical insulation is to be provided by Contract D-29 : Paint. See changes to the specifications included in this addendum.
- 329. Which Contract shall provide and install the Black Sound Acoustical Board insulation on the bottom of roof decks where indicated?
 - a. The black sound acoustical board insulation as specified in Section 098100 is to be provided by Contract D-25: Metal Studs & Drywall.
