Work for materials not specifically mentioned herein are to be described in the main body of the specifications and as shown on the drawings. Bidders shall acknowledge receipt of this addendum on the space provided on the Bid Form. Failure to do so may subject the bidder to disqualification.

The contract documents for the above referenced project are amended as follows:

**GENERAL CLARIFICATIONS:**

QUESTIONS AND ANSWERS:

- 1) Please provide greater detail on the 20' tall Ball Netting.
  - a. Please see specifications and installation instructions for the 2 netting options included in this Addendum.
  - b. 2 netting options have been provided. Please price the Aluminum Athletic Equipment BallStopper Sports Netting (Prod # MBS-20) as Alternate #42 and the Sportsfield Specialties Storm Guard Netting System. (Prod # BSS420) as Alternate #42-A on the revised bid form included in this Addendum.
  
- 2) Is the Post and Cable not part of Contract F-52 Fencing?
  - a. Correct, Post and Cable is not part of Contract F-52.
  
- 3) Is the fencing contractor going to be responsible for any Permits?
  - a. No, all permits will be applied for and purchased by EDiS Company.
  
- 4) Is Sturdi Steel an acceptable substitute for the Grandstand, Bleachers and Press Box
  - a. Subject to compliance with requirements, the following manufacturers are also approved: Sturdisteel Company. Note specific comment for press box: see requirement for work bench support in 133416 2.03G-1h.
  
- 5) Please provide detail showing the Fieldhouse Entrance Gate and Associated Posts
  - a. Fieldhouse Entrance Gate and Associated Posts is by Steel Contractor. Alternate #43 for the Fieldhouse Entrance Gate is deleted in the revised bid form included in this addendum.
  
- 6) We found a discrepancy with the written specifications and the fence details shown on plans regarding the type of chain link fabric to be used and post sizes to be used. Please inform if the fence details shown on plans are to be what is required for the chain link fence fabric and post sizes to be used or if we should follow the written specifications in section 323113 for these items.
  - a. Use the fence fabric and post sizes stated in the plan details rather than what is in the written spec.
  
- 7) On drawings C-121= the 40'w double and 40' slide gate, and C-125= 40'w double gate, the heights are not specified. They look to be stand alone gates. Are these to be 6' tall?
  - a. The 40' wide manual double swing gates are detailed on sheet C-501. The height of the ornamental sliding gate at the loading area is 8'-0". This gate, including operators, is specified in Section 323119. Please disregard these fences. These gates are by the Site Contractor

  - a. DELETE pages 004100-9 through 11 and REPLACE with revised Pages 004100-9 through 11 attached to this addendum.
    - Added ALTERNATE #42-A : Provide Safety High-Net Backstops at Fields 4, 5, and 6. Include excavation/augering, forming, and placing concrete footings as required for the support posts.
  
- 2) BID PAC F – VOL 1 SPECIFICATION SECTION 011100 : Summary of Work – Contract F-52 : Fencing
  - a. Page 9 – DELETE Bullet 4 and ADD the following – “ALTERNATE #42 : Provide Aluminum Athletic Equipment BallStopper Sports Netting (Prod # MBS-20) at locations shown as Safety High-Net Backstops at Fields 4, 5, and 6 on the Civil Plans. Include excavation/augering, forming, and placing concrete footings as required for the support posts. Specifications and Installation Instructions for the AAE Ballstopper Sports Netting are included in BPF Addendum #2.
  - b. Page 9 – ADD Bullet 4A – “ALTERNATE #42-A : Provide Sportsfield Specialties Storm Guard Netting System. (Prod # BSS420) at locations shown as Safety High-Net Backstops at Fields 4, 5, and 6 on the Civil Plans. Include excavation/augering, forming, and placing concrete footings as required for the support posts. Specifications and Installation Instructions for the Sportsfield Specialties Storm Guard Netting are included in BPF Addendum #2.
  - c. Page 9 – DELETE Bullet 5 – “ALTERNATE #43 : Provide Fieldhouse Entrance Gate and associated posts. Include excavation/augering, forming, and placing concrete footings as required for the entrance gate posts.”
  
- 3) BID PAC F – VOL 1 SPECIFICATION SECTION 012300 : Alternates
  - a. DELETE Alternate No. 42: Provide Tall Ball Netting at Fields 5 & 6 and ADD the following:
    - Alternate No. 42: Provide AAE BallStopper Sports Netting at Fields 5 & 6
      - a. Base Bid: No tall ball netting is to be provided under base bid.
      - b. Alternate: Contract F-52 is to provide Aluminum Athletic Equipment BallStopper Sports Netting (Prod # MBS-20) at Fields 5 & 6 including excavation/augering, forming, and placing concrete footings as required for the support posts.
  - b. ADD Alternate 42-A as follows:
    - Alternate No. 42-A: Provide Sportsfield Specialties Storm Guard Netting System at Fields 5 & 6
      - a. Base Bid: No tall ball netting is to be provided under base bid.
      - b. Alternate: Contract F-52 is to provide Sportsfield Specialties Storm

Guard Netting System. (Prod # BSS420) at Fields 5 & 6 including excavation/augering, forming, and placing concrete footings as required for the support posts.

- c. DELETE Alternate No. 43: Provide Fieldhouse Entrance Gate and Associated Posts
