#### **QUESTIONS AND ANSWERS:**

- 3. General Notes G12 through G14 on Sheet S002 is missing information on the load schedule. Please provide.
  - a. Load Schedules are shown on Drawings S003. We will provide correct reference on Sheet S002 in Addendum #3.
  - b. **Update 12/15/17** Information provided in Addendum #3
- 4. Structural design of orchestra pit does not match architectural. Please coordinate.
  - a. Orchestra Pit Extents is Being Revised. We will provide additional information in Addendum #3.
  - b. Update 12/15/17 Information provided in Addendum #3
- 7. Provide details/cuts through end walls of the orchestra pit (north and south)
  - a. We will provide additional details in Addendum #3 once revisions to the extent of the pit is completed.
  - b. Update 12/15/17 Details provided in Addendum #3
- 9. Current structural design of the orchestra pit has steel columns located in the middle of planned doorways. Please coordinate between architectural and structural design.
  - a. Orchestra Pit Extents is being revised. We will provide additional information in Addendum #3.
  - b. **Update 12/15/17** Revised Orchestra Pit Wall & Column Layouts provided in Addendum #3
- 12. Areas C and D (Sheets S113 and S114) need more detailing of the foundation walls to allow for bidding. Please provide section and wall cuts for the exterior and interior walls.
  - a. See updated drawings included in Addendum #1. Additional details are to be provided in Addenda #2 and 3.
  - b. Update 12/15/17 Additional details provided in Addendum #3
- 19. Sheet S118.A needs much more detailing. All notes appear to be pointing at wrong locations, individual piles are not called out, and details/sections are required at exterior and interior foundation walls. In addition, the gymnasium slab type called out on Sheet S118A does not match the slab type of the original gymnasium slab.
  - a. Sections & Slabs will be coordinated in Addendum #3. Provide similar details shown on Sheet S118.
  - b. **Update 12/15/17** Alternate Gym Foundation Additional Details Provided in Addendum #3
- 47. Is PRECON Blindside Waterproofing / Underslab Membrane by W.R. Meadows an acceptable substitution for the specified waterproofing product?
  - a. See modifications to specifications included in this Addendum #3.
- 48. Please confirm the elevation of the inverts of the sanitary sewer for the main buildings. The table provided on Sheet C-400 only provides 3 invert elevations (1 each for the high school, PAC, and middle school); but there are six invert locations shown on the plans. In addition, the invert provided for the PAC is at 34.38, but the plan shows the invert of the clean out 5′ outside of the building at 37.32.

- a. The inverts you are referring to on the chart on C-400 are the lateral inverts at connection points to the sanitary main (for the example you gave, see that MH 10-4-4 invert is the 34.38) not the invert at the building. This is a county required chart from their checklist. The chart on C-400 has been updated to add the laterals exiting the HS area (at gym and at loading area to MH 10-4-8) and the lateral exiting the kitchen area (to MH 10-4-6)
- 49. Please provide invert elevations for the stormwater sewers exiting the building. Also, what is the size and depth of the perimeter stormwater drain? The downspouts all tie into this pipe, along with the stormwater sewers exiting the building, some of which are 10" diameter or larger.
  - a. The 'in' and 'out' inverts can be found in the Roof Drain Pipe Schedule that was added to revised Sheet C-154 that was issued with Addendum #2. A Roof Drain Pipe Schedule was added to revised Sheet C-154 that was issued with Addendum #2
- 50. The legend references "concrete pad". This "concrete pad" appears across the site intermixed with other sidewalk. Please provide a detail for this area.
  - a. These are areas that the fire marshal required to be stonger to be accommodate emergency vehicles. A revised Sheet C-500 is included with Addendum #3 with the sidewalk detail clouded. This detail now includes a reference to the heavy duty sidewalk area.
- 51. Can you confirm fieldhouse is in base bid for foundation bid but the Natatorium is not.
  - a. Neither the fieldhouse nor the natatorium are included in this bid package's concrete or masonry contracts. The only work to occur at the fieldhouse as part of this bid package is the timber piles.
- 52. On sheet S-301, what is the top of concrete walls per detail 3/S507.
  - a. Typically 2'-3" from high slab to top of wall.

The Concrete Contractor is responsible for laying out concrete foundations, grade beams, and pile caps, excavate around the driven piles, and cut off the remaining timber piles to the final elevation. The concrete contractor is responsible to remove the pile cut-offs from site.
