1.0 GENERAL NOTES:

- 1.3 Bidders shall verify that their Sub-bidders are in full receipt of the information contained herein AND in future addendums posted on the State's website.
- 1.4 All addenda will be sent out to the registered plan holders via email (or fax) unless full size drawings are issued only as a courtesy. Contractors are encouraged to keep an eye on their email accounts during the bidding periods for such updates.

2.0 **Revisions to the SPECIFICATIONS**

2.1 None at this time.

3.0 Revisions to the DRAWINGS

- 3.1 REVISED 3/A70-2 See sketch AD2-SK1 attached
- 3.2 REVISED 4/A50-1 See sketch AD2-SK2 attached
- 3.3 REVISED 1/AD11-1 See sketch AD2-SK3 attached. Added demolition of soffit in Lounge D196.
- 3.4 REVISED 4/A70-2 See sketch AD2-SK4 attached. Added soffit to Lounge D196.

4.0 Questions

- Q.1 The new 2-1/2" pipe in Lounge D196, is it to be exposed in the room?
 - A.1 Pipes to be run in new soffit, see AD2-SK3 for demolition of existing soffit and AD2-SK4 for installation of new soffit.
- Q.2 Clarify there are no mechanical or electrical specs other than what's on the drawings
 - A.2 M/E specifications are on the drawings.
- Q.3 Clarify there is no tie in to any existing ATC system
 - A.3 We will not be tying into the existing ATC system. Units will be stand alone. Contractor shall own all interconnecting wiring between the controller, valve and motorized damper.
- Q.4 If the alternate add is taken can both sides be done at the same time?

A.4 Yes.

- Q.5 Drawing ED-2 shows an existing panel on the hallway D192 but it could not be located during the site visit, where is this panel located?
 - A.5 Delete reference to panel.
- Q.6 Drawing ED-2 Drawing Note 5 refers to providing backboxes and conduit for telecommunication devices to be coordinated with the district; can more information be provided for bidding purposes including quanity and type of backboxes, size of conduit and where the conduit needs to be run to; if these answers can't be provided can this work be completed in the form of an allowance?
 - A.6 Delete any reference to back boxes and conduits.
- Q.7 What panels are the existing unit ventilators fed from? Where is it located?
 - A.7 Christina School District is currently working on providing a list of electrical feeds from panel. Once list becomes available, the information will be forwarded.

- Q.8 On Drawing E-2 the lighting is references with Drawing Note 1 (which seems to apply to the fan coils), should the lighting be references with Note 5 or Note 6 instead?
 - A.8 Use notes 5 and 6.
