A.2 **NO!** All cuts shall be factory made using the “Linear Options” program with the exception of vertical cuts at wall corners, door frames, and tiles abutting ceilings.

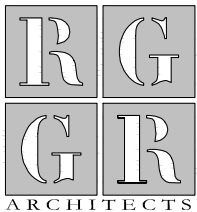


## RENOVATION PLAN
