12. Please confirm that the Nurse to student ratio is 1:25.	1 nurse for every 40 division 1 units (approx. 840 students). A nurse is required to be on premises
13. Will the Nurse be allocated to only the students of this program? Can the Nurse deliver services to students outside of this program?	The provider must provide a nurse on site, to meet state of Delaware requirements. The nurse must provide services to the student attending the program.
14. Does the nurse need to be full time - or can the nurse be part time?	A nurse must be available at all times when students are in the building.
15. School meals and equipment to keep the breakfast/lunches/condiments cold or hot - will this be provided by the district?	Currently this is provided by the current provider, it is expected that any other provider contracted will continue this same service
16. May we offer a cost proposal that is cost-per-student, thus allowing the district to determine how many students it wants to send and the associated cost of doing so? This would be versus offering a budget and cost proposal to operate the entire program.	Yes.
17. "The total number of students at any one time is 25"; What percentage of the students will have an IEP?	Normally approximately 75 percent of the students are special education with IEP's.
