<p>13. How many working days will the SLP, OT, PT, BCBA and SSP work during the school year (For Example: 180 days or less)?</p>	<p>194 in Wilmington Schools and 180 in other schools</p>

If the proposal response should be submitted in separate sealed envelopes, is it acceptable for the vendor to submit the separate sealed envelopes in the same package OR do you prefer the separate submittals not packaged together?</p>	<p>It can be in the same package as long as each submission is clearly marked with RFP number.</p>
<p>15. Would the district pay for mileage travelling between school campuses on the same day? If so, what will be the district IRS Standard Rate?</p>	<p>No, district does not pay mileage. The hourly rate must be all inclusive</p>
<p>16. Will this include summer school and the extended school year?</p>	<p>Possibly depending on need</p>
<p>17. If your staff are all Master's level, would the expectation be that you have a BCBA in a leadership or consulting role?</p>	<p>Not necessarily</p>
<p>18. Should the rate be submitted/broken down by staff by hour or daily rate? What billing mechanism would you like us to submit- by day or hour?</p>	<p>Rate must be hourly all inclusive. Billing will be based on number of hours per day</p>
