### Amakor:

- 4.1 Is the school providing the phone/data for this job? They show some outlets on the drawings, but there are no specs. **ANSWER:** *Data/Phone is in the base bid and the responsibility of the General Contractor.*
- 4.2 There are card readers on the drawings. Is the owner providing card access? ANSWER: Card Access is NOT by Owner. The card access/ readers and their associated hardware, parts, programming and wiring are the base bid and are responsibility of the General Contractor. The card access is an extension of the school/ districts existing system. Contact Steve Redden, Anaconda Protective Concepts, (302) 834-1159.
- 4.3 Will door #2 require an automatic or electrically assisted opener?ANSWER: Door #2 will not have a power door opener but does have an electronic release functionality as specified in the hardware schedule.
- 4.4 On the door schedule, door #10 is listed as type D4. D4 door type shows glazing. No glazing is specified on the schedule. Please clarify.ANSWER: Door #12 to have tempered glazing.

### **BSS Contractors:**

4.5 On the door schedule, Door #12 does not have a verified door size. Additionally, more of the jamb depths are not identified as well.

**ANSWER:** Assume Door #12 is 3'-0" wide x 6'-9" high. According to original drawings - the jamb is similar to J2 with the exception that the face of the frame is 1". The stop is 5/8" deep, the overall depth is 6-3/4" and the Rabbet is sized for a  $1\frac{3}{4}$ " door.

### The Cobi Group, Inc.:

4.6 Is Danback Wood Blocking acceptable to use in lieu of 2"x6" blocking? ANSWER: Yes this is acceptable alternative to 2"x6" blocking.

- 2. Project consists of the following:
  - a. The general scope of the project entails converting an existing classroom into a Wellness Center which includes an exam room, counseling room, small sampling lab and office area. Major scope items include new concrete ramp, new partitions, doors/frames/hardware, casework and associated MEP work including a new packaged rooftop unit.
  - b. Project will be constructed under a single prime contract with a General Contractor. Form of Contract will be AIA Document A101 Standard Form of Agreement between Owner and Contractor where the basis of payment is a STIPULATED SUM.
- 3. Prequalification: The following Contractors must be prequalified with the State of Delaware:
  - The General Contractor
  - The Mechanical Contractor
  - The Electrical Contractor
- 4. Bids Due: Sealed proposals will be received by the Owner for public opening until 2:00 p.m. local time on Wednesday, August 2, 2017 at the Colonial School District's Administration Building, 318 E. Basin Rd., New Castle, DE 19720. Proposals received after this time shall not be accepted. Bidders should be aware that the Owner reserves the right to reject all bids and/or negotiate with the low bidder.



- 5. Availability of Documents: The contract documents (project manual and drawings) will be made available at the non-refundable cost of \$50.00 per set. The documents will be available for purchase at the Pre-bid meeting or at the architect's office after the Pre-bid meeting. Payment is to be made by check payable to the order of "Tetra Tech."
- 6. Wage Rates and Payroll Reporting: Contractors shall comply with all requirements of the State of Delaware regarding prevailing wage rates and payroll reporting shall be reported to Delaware Department of Labor.
