

## INVITATION TO BID

Sealed bids for the Capital School District 2016 Asbestos Abatement for the Locker Replacement Project at the William Henry Middle School will be accepted **until 2:00 p.m., local time on Tuesday, October 27, 2015 at the Capital School District, District Office, 198 Commerce Way, Dover, Delaware 19904.** Bids will be publicly opened, read, and recorded.

The work consists of interior abatement of asbestos-containing transite panels, joint compounds and spackling, floor tiles and associated mastics at various locations within the school building. Work will be performed starting on or about June 13, 2016 and must be completed within thirty (30) calendar days.

PLEASE SIGN-IN AT THE MAIN OFFICE LOCATED IN THE FRONT OF THE BUILDING. ATTENDANCE AT THIS MEETING IS A MANDATORY PREREQUISITE FOR SUBMITTING A BID ON THIS PROJECT. EACH PROSPECTIVE BIDDER MUST BE REPRESENTED BY A FULL-TIME EMPLOYEE OF THAT COMPANY. ATTENDEES MAY NOT REPRESENT MORE THAN ONE COMPANY.**

Bidding documents will be provided upon receipt of \$ 100.00 per set (non-refundable). Checks are to be made payable to "Compliance Environmental, Inc." Major credit cards accepted.

The bids may not be withdrawn for a period of sixty (60) calendar days after the scheduled closing time for receipt of bids.

A bid bond is required. A performance bond and payment bond is required if the based bid is greater-than \$ 50,000.00.

The Capital School District may extend the time and place for the opening of bids from that described in the advertisement on not less than two (2) calendar days' notice, by certified delivery, facsimile machine, or other electronic means to those bidders who obtained copies of the bidding documents.
