

ADVERTISEMENT FOR BIDS

Sealed bids for **DEARNG Contract No. 15-008 – Delaware Army National Guard (DEARNG) Bethany Beach Training Site Fire Alarm and Fire Protection**, will be received by the Delaware Army National Guard at the Security Officers desk in the Main Lobby of the Armed Forces Reserve Center located at 250 Airport Road, New Castle, Delaware, 19720-1502, until **10:00 AM local time on Tuesday, December 22, 2015**, at which time they will be publicly opened and read aloud in the Multipurpose Room located next to the main lobby. Valid driver's license will be required for site access, front desk where all visitors are required to sign in at the Security Desk. **Bidder bears the risk of late delivery.** Any bids received after the stated time will be returned unopened.

Project will take place at the DEARNG Bethany Beach Training Site located 163 Scannell Blvd Bethany Beach, DE 19930-0985. Basic scope of project involves the installation of fire suppression/fire alarm systems and all associated work for buildings 115, 139 and 140.

Attention is called to construction schedule in the Contract Documents.

Valid identification required for access; additionally all visitors will access site thru the South entrance of the complex.

The purpose of this pre bid meeting is to review the bid documents, bidding instructions and establishing a list of contractors and sub contractors for this project. The established dates and times for the site visits are the only opportunities that contractors / subcontractors will have to complete measurements, take pictures, etc. as the facilities are not open to the public. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informality therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
