- 1.0 This addendum, Addendum No. 2, shall be made part of the Project Manual and Drawings dated March 7, 2016 for the Fire Alarm & Fire Suppression Systems at the Delaware Army National Guard Duncan Readiness Center.
- 2.0 Any provision in any of the Contract Documents which may be in conflict or be inconsistent with the contents of this Addendum shall be void to the extent of such conflicts or inconsistency.
- 3.0 **Bid date, time and location have not changed.**
- 4.0 Changes to Specifications
  - 4.1 Section 00 41 13 Bid Form:
    - A. DELETE existing Bid Form in its entirety and REPLACE with revised Bid Form attached, to reflect Allowance for Artesian Water Costs.
  - 4.2 Substitutions: No substitution requests were submitted. Only specified vendors will be permitted.
- 5.0 Changes to Drawings:
  - 5.1 There are no changes to the Drawings.
- 6.0 Questions/Clarifications
  - 6.1 Can you please clarify the scope of work and extent of services to be provided by Artesian Water?
  - 6.1 Reply:

As shown on Drawing C-2, all costs for labor and material for paving, installation of the 8"x6" Tapping Sleeve & Tapping Valve, all piping up to the property line including the 6" water valve is to be included in the scope of work by Artesian or by Artesian's contractors. All work to connect to the 6" water valve at the property line, piping, valve vault and piping into the building including sidewalk restoration, is to be included in the scope of work by the Prime Contractor. Omit clarification provided in 19.Q1 in Addendum #1

To simplify the costs to be included by the contractor for work by Artesian, an allowance in the amount of \$25,000.00 will be included in the revised Bid Form. Once actual costs are identified during construction, an add or deduct change order will be applied to the Allowance as identified in Specification Section 01 21 00.
