Sealed bids for **DEARNG Contract No. 03-2016 – Duncan Readiness Center Fire Protection Systems**, will be received by the Delaware Army National Guard at the Security Officers desk in the Main Lobby of the Armed Forces Reserve Center, 250 Airport Road, New Castle, Delaware, 19720 until **2:00 PM local time on March 31, 2016**, at which time they will be publicly opened and read aloud in the Multi-Purpose Room.
