- 5.0 Changes to Specifications
 - 5.1 Section 26 32 13, Article 2.6A, Refer to Addendum #3 article 6.1.A below.
- 6.0 Changes to Drawings:
 - 6.1 Drawing E-3 Single Line Diagram- New Work (ADD ALTERNATE #2)
 - A. Change Generator Output Circuit Breaker to 3P-400A Frame with 225A trip. Breaker shall be Electronic, fully adjustable with L,S and I settings. Settings to be determined by Power System Study.
 - B. Change feeder from generator to ATS from Feeder Type 2 to new Feeder Type 13. Type 13 Feeder shall be 2-4" C; 1 w/4-300kCMIL & 1-#1/0GND and 1- 4" C Spare.
 - C. Omit 3P-400A Nema 1 Enclosed Emergency Breaker ahead of ATS.
 - D. Provide new generator emergency stop switch adjacent to Emergency side of ATS. Provide connections to generator per manufacturer's instructions.
