TERMS OF CONTRACT EXTENSION:	<p>The undersigned hereby agrees to extend the existing Inmate Substance Abuse and Mental Health Contract No. DOC1202-MENTAL for the period of July 1, 2016 thru June 30, 2017, with the following amendments:</p> <p>Both parties agree that the annual base compensation for final extension year 5 (FY17) shall be \$13,148,346.31, which reflects a two percent (2%) increase over the FY16 annual base compensation. In addition, the annual base compensation for the New Expectations Program shall remain the same compensation as the FY16 rate of \$144,970.56 (\$12,080.88 per month). Both parties further agree to remove the 25% annual performance bond requirement listed on page 73 of original RFP for the final extension term in exchange for an increase in staffing and other consideration totaling \$222,236. Vendor agrees to increase the staffing levels at James T. Vaughn Correctional Center by one (1) Psychologist @ \$98,091; 0.4 Psychiatric Nurse Practitioner @ \$61,417; and one (1) Activity Tech @ \$43,728. The balance of consideration totaling \$19,000 shall be utilized by Connections to operate the New Expectations Program.</p> <p>All other services rendered shall be in accordance with the same terms and conditions as set forth in the original contract effective July 1, 2012 and any subsequent addendums. This contract will expire on June 30, 2017 having no further optional extensions.</p>
