Offenders must be notified of this fee in writing prior to the scheduled examination date. Vendor will be solely responsible for collecting this fee.➤ \$1,125.00 – Individual Counseling Sessions – 25 hours @ \$45/hour \$25-\$50/hour➤ \$175,875.00 \$175,967 Group Therapy – Approximately 30 150 groups/week month @ \$62.50 \$80.00 per 60 minute group; and Evaluations @ \$15.00 - \$70.00/evaluation. <p>All other services rendered shall be in accordance with the same terms and conditions as set forth in the original contract dated December 1, 2015 – June 30, 2016.</p>
