8	When is the anticipated or estimated notice-to-proceed date?	This information is not currently available.
7	Will the consultant design engineer be permitted to submit as a prime consultant or sub-consultant?	Yes. This response is being revised effective March 28, 2013 to "No". The design engineer is not allowed to participate.
6	What is the final deadline for asking questions regarding the RFQ, responses to questions or the technical project details?	Friday, April 5, 2013.

5	Section D.2.d. notes that the Similar Projects section "shall be limited to ten (10) similar projects and shall not exceed two (2) pages in length." Please clarify whether this means we have a total limit of 2 pages to show 10 projects (approx. 5 projects on each of the 2 pages), or does this mean we have 2 pages allowed per project for a total limit of 20 pages for this section?	Two (2) pages allowed per project for a total limit of ten (10) double-sided pages.
4	project personnel have been with the submitting firm for less than one (1)	Section D(2)c of the RFQ states "Staffing information can be either shown as two (2) individuals per page/sheet, or <u>one (1) individual per page/sheet</u> ." This should be enough space to include the work history <i>and</i> relevant project experience.
3	Section D regarding the response utilizing a 330 or 255 - "Item # 4, Personnel by Discipline, the consultant shall document clearly personnel by discipline presently employed at the work location proposed and their availability for assignment to this project." Item 4 refers to a portion of the 255 format and there is not a similar section in the 330. How would you like for those of us utilizing the 330 to respond to this?	Item #9 on page 5 of Form 330 gives instructions for this.
2	Section C r equests a Project Organization Chart. This is already a standard part of a SF 330 form (330 Section D). Do we need to duplicate it in a tabbed section as well as in the 330?	The Project Organization Chart should be a separate section (tab) in your submission.
1	Section 2.B. Letter of Interest under the Expression of Interest Requirements on page 4 of the RFQ notes "Limited to four (4) pages on two (2) sheets of paper" and then in Section E References notes an "eight page Letter of Interest." How many total pages do we have for the Letter of Interest? Is duplex (two-sided) printed desired or required?	The Letter of Interest should not exceed four (4) pages, on two (2) sheets on paper.
