The Department desires to purchase a Solar Energy System for a minimum of two locations. The project will retrofit DTC facilities with photovoltaic (PV) solar panels to generate costs savings through reductions of fossil fuel energy use. The power will be used to power lighting, computers, air conditioning, and other daily electric loads of the buildings.
