**PROJECT INFORMATION**

This Request for Proposal (RFP) issued by the Delaware Department of Transportation is for the purpose of acquiring Proposals from interested firms to provide an estimate for the specific services or tasks that may include designating, locating, utility design and/or coordination. The consultant shall provide all equipment, personnel and supplies to perform the aforementioned services assigned by DelDOT.

**PROFESSIONAL SERVICES REQUIRED**

Services include but are not limited to the following: Engineering, Surveying and Design

**PROJECT DESCRIPTION**

**A. SUBSURFACE UTILITY DESIGNATING:** Using geophysical prospecting techniques to determine the existence and horizontal position of underground utilities.

1. Meet with DelDOT to discuss specific project scope.
2. Provide proposal to DelDOT on project.
3. After authorization is given to consultant by DelDOT to perform these services on a specific project, consultant shall obtain permits as necessary.
4. The consultant will secure necessary plans, as-builts, plats, or other documents from DelDOT and utility companies.
5. The consultant will provide signs, safety devices, and flagmen as specified by DelDOT.
6. The consultant will designate, measure, and record the approximate depth and location of the existing utilities and their laterals to existing buildings within the project limits. For collection associated with a DelDOT 3D modeling design and as otherwise requested by DelDOT, the consultant will be required to provide approximate depth information via instrument readings or other means along with an explanation for the accuracy/reliability for the information. The

consultant may be requested to draft utility locations in Microstation on plan sheets furnished by DelDOT in the format of Intergraph or in accordance with the Department's CADD standards.

7. The consultant shall deliver final product to DelDOT in the required format.

**B. SUBSURFACE UTILITY LOCATING:** Using nondestructive excavation equipment at critical points along a subsurface utility's path to determine the precise horizontal and vertical position of the underground facility.

1. Meet with DelDOT to discuss specific project scope.
2. Provide proposal to DelDOT on project scope.
3. After authorization is given, the consultant will obtain and review plans from DelDOT and utility companies.
4. The consultant shall obtain necessary permits from appropriate parties.
5. The consultant shall call "Miss Utility" and comply with current underground utility protection laws.
6. The consultant shall coordinate work activities with DelDOT and utility representatives by conducting "kick-off" meetings.
7. The consultant shall provide traffic control devices in accordance with the Delaware MUTCD.
8. Work is to be performed by neatly cutting an area not exceeding 225 square inches and excavating, using the vacuum extraction method, and exposing the utility to obtain necessary data.
9. Data collection includes furnishing and installing a permanent aboveground marker (i.e. P.K. nail, peg, steel pin, or hub) and color-coded ribbon directly above the centerline of the structure and record the elevation of the marker.
10. Where applicable, the consultant will provide permanent restoration of pavement within limits of the original cut at time of backfill. Whenever test holes are excavated in areas other than roadway pavement, these disturbed areas shall be restored, as nearly as possible, to the condition that existed prior to excavation.
11. Whenever possible, the consultant shall tie all vertical controls to a minimum of two (2) checked benchmarks or available datum. The consultant shall complete turns, or establish additional benchmarks, as required to obtain the tie. The accuracy of these turns or additional benchmarks shall be in accordance with established surveying practices.
12. The consultant shall plot the horizontal position of the located utilities on the furnished plans.
13. The consultant shall plot profile of the located utilities on the furnished plans.
14. The consultant shall return plans, profiles, and certification forms and review same with DelDOT's engineer, as deemed necessary.
15. At grade utility appurtenances (valves, manholes, etc.) that are discovered, and not provided in DelDOT documents, shall be surveyed for horizontal location and plotted. Additionally, manholes shall be accessed so additional information can be recorded and provided to DelDOT. Information to include measure downs/inverts, pipe sizes, configuration, pipe structure material and flow direction.
16. The consultant shall provide the following test hole information on a certified test hole data sheet and will also summarize data into a table format.
  - Elevation of tops and/or bottom of utility tie to the datum of the furnished plan.

- Elevation of existing grade over utility at test hole.
  - Horizontal location using a minimum of three (3) swing ties to physical structures existing in the field and shown on the DelDOT plans.
  - Outside diameter of pipe or width of duct banks and configuration of non-encased multi-conduit systems.
  - Utility structure material composition, when possible.
  - Identify benchmarks used to determine elevations.
  - Elevations provided by the consultant shall be within an accuracy of +/-0.05" based on the benchmarks shown on the DelDOT plans.
  - Provide paving thickness, where applicable, and the general soil type and site conditions.
  - Identify the owner/operator of utility facility
17. The consultant shall not proceed with any work until DelDOT has issued a "Notice to Proceed" for a specific project.
18. All information will be provided within thirty (30) days of completion.
19. The consultant shall immediately notify the assigned DelDOT utility coordinator if they run into problems or are unable to obtain information requested. The consultant should use due diligence to locate all requested utility facilities (active or abandoned) regardless of material and should have tools and procedures in place to aid in difficult situations.

- C. UTILITY COORDINATION:** Act in behalf and at the direction of DelDOT to administer the Federal and State laws regarding utility relocations necessitated by transportation related projects. Conduct coordination meetings with utility companies to discuss proposed highway plans, relocation of utilities, cost responsibilities, scheduling and construction. Assume timely and appropriate generation, collection, dissemination, storage, and disposition of project information. Work together with DelDOT and utility representatives to find solutions that will enhance and promote the efficient relocation/installation of utility facilities.
- D. UTILITY DESIGN SERVICES:** Provide utility design services, as directed by DelDOT, for those facilities determined to be in conflict with the proposed highway plans. Utility relocation designs for water, sanitary sewer, gas, etc., shall be in accordance with the requirements of the affected utility company. Prepare a preliminary design for the relocation depicting the relocation's horizontal and vertical alignment and required appurtenances (i.e. manholes, valves, etc.) for review. Provide an estimate of the proposed relocation costs and a unit cost breakdown of specific pay items shown to be constructed. Provide final design plans, details, unit cost estimates, and special provision on individual projects. Prepare contract plans for bid in accordance with DelDOT standards for plan preparation. Coordinate proposed relocation designs with DelDOT designers, utility companies and DelDOT utility staff.
- E. UTILITY & INFRASTRUCTURE INSPECTION SERVICES:** Provide utility & infrastructure inspection services, as directed by DelDOT, for relocation and/or installation work within State ROW or on state owned lands. Such work would include coordination between utility companies, the

DelDOT Utility Section, DelDOT Construction personnel and any other necessary parties on survey stakeout; when utility work will begin; schedule and timing of work; MOT needs; clearing needs; etc. Consultant inspection personnel will be required on-site at all times there is utility or infrastructure work to ensure facilities are installed in a manner that does not conflict with the most current DelDOT highway design. As part of this, the consultant will be required to obtain and keep up-to-date as-built information on the utility work and supply to DelDOT.

**F. TRAINING AND OTHER RELATED SERVICES:** Provide training and instruction to the utility industry on DelDOT and FHWA utility relocation policies and procedures related to proposed transportation projects. Review and make recommendations for possible updates to current utilities manual and/or accommodations policies. Other related services as may be deemed appropriate by DelDOT such as on-site construction management of utility relocations.

**DISADVANTAGED BUSINESS ENTERPRISE**

A four percent (4 %) DBE goal has been established for the sum total of all federally-funded tasks associated with this Agreement. The Department will require ongoing reviews and approval of *good faith efforts* before a Notice to Proceed is issued. Department DBE Program staff will monitor this Agreement to ensure that good faith efforts are being made to meet the DBE goal. DBE firms must be certified through DelDOT's DBE Program in order to qualify toward meeting the goal.

2. **The Prime Consultant must be Registered**, or submit application for registration with DelDOT at or before the time of submission in order to be considered. For registration information, click [here](#).
3. **Submit one (1) original and five (5) hard copies** of the Proposal. Receipt of insufficient copies or non-compliance with providing the requested information in the desired format, may negatively impact the scoring.
4. **Submit two (2) pdf format electronic copies** (e.g. CD, flash drive) of the Proposal; one original and one a redacted copy. The original must be a .pdf file of the original signed proposal as submitted and should be clearly marked “Original”. The redacted copy must be a .pdf file of the original signed proposal with any proprietary or confidential information redacted, and this copy should be clearly marked as “Redacted”. Electronic copies are to be submitted with the printed Proposal. The electronic redacted copy is required even if the submission contains no proprietary or confidential information.

7. **DelDOT reserves the right to reject** any and all submissions. Submissions become property of the Department and shall be retained electronically for a minimum period of three (3) years from the date of receipt. DelDOT reserves the right to any and all ideas included in this response without incurring any obligations to the responding firms or committing to procurement of the proposed services.
8. **Required Certification Forms.** All firms responding to the RFP must complete and return the submission forms located in 'Appendix A' of this document.

No promotional materials or brochures are to be included as part of the submission.

## **OVERVIEW OF SELECTION PROCESS – IDIQ**

- This is an indefinite delivery/ indefinite quantity agreement utilized for the performance of services for a number of projects under task orders issued on an as-needed basis. The dollar value of each individual agreement cannot exceed one million, five-hundred thousand dollars (\$1,500,000.00). There is no guarantee of actual agreement value.
- This is a single phase solicitation process with the availability for discussions with five (5) of the most highly qualified firms. Based upon the listed criteria and evaluation of each firm's submitted proposal, the Selection Committee may decide if a small sample task and/or discussions will be held with the most highly qualified consultants. If discussions are held, they will serve to clarify the technical approach, qualifications, and capabilities provided in response to the RFP, after which the committee will determine the ranking of the candidate firms.
- Selection Committee members will individually score each firm's submitted proposal which determines individual ranking. The Department's ranking is the combined ranking of all Committee members. Awarded firms, in order of ranking, will have the opportunity to negotiate an agreement with the Department. If the Department cannot reach agreement with the highest ranked firm(s), the Department terminates negotiations and begins negotiations with the next highest ranked firm, and so on until an agreement is reached. The Department notifies via email the awarded firm(s) of the opportunity to enter

into an agreement with the Department. This notification also includes information on the next steps for the agreement process.

- After the ranking process has been completed, applicable price information will be requested from the successful candidate firm(s), such as; salary rates for various classifications of personnel; and an indirect cost derivation for the most current accounting period.
- Payroll burden and overhead will be computed on direct salary costs only (not including overtime) at the consultant's audited rate, as per Federal Acquisition Regulations Part 31, and Department policies. Computer and CADD costs are not allowable as a direct cost to this project. Rate determination and applicability is subject to audit by the Department. Additionally, candidates should be prepared for the Department to work with your current accounting firm to provide information and backup documentation. Full and immediate cooperation is required to avoid delays in execution of an agreement. Failure to cooperate may result in breaking off of negotiations and moving to the next ranked firm.

- Each specific task order shall be awarded to the selected, qualified consultants through an additional qualifications-based selection procedure, which may include, but does not require, a formal IDIQ RFP;

### **MISCELLANEOUS**

The Department is not liable for any cost incurred by the consultant in the preparation or presentation of the Proposal.

Any individual, business, organization, corporation, consortium, partnership, joint venture, or any other entity including subconsultants currently debarred or suspended is ineligible to participate as a candidate for this process. Any entity ineligible to conduct business in the State of Delaware for any reason is ineligible to respond to the RFP.

The Department of Transportation will affirmatively insure individuals and businesses will not be discriminated against on the grounds of race, creed, color, sex, or national origin in consideration for an award. Minority business enterprises will be afforded full opportunity to submit bids/proposals in response to this invitation.

### **FEDERAL CONTRACT PROVISIONS**

FTA's Master Agreement contains a current, but not all-inclusive, description of statutory and regulatory requirements that may affect a recipient's procurement (such as Disadvantaged Business Enterprise (DBE) and Clean Air requirements). The Master Agreement states that applicable Federal requirements will apply to project participants to the lowest tier necessary to ensure compliance with those requirements. The recipient will need to include applicable Federal requirements in each sub-agreement, lease, third party contract, or other document as necessary. For specific guidance on cross-cutting requirements administered by other Federal agencies, FTA recommends that the recipient contact those agencies. The requirements listed herein must be adhered to by any firms selected to perform work required under these agreements.

**1. AUDIT AND INSPECTION OF RECORDS**

The Contractor agrees to provide the Delaware Department of Transportation (Department), the FTA Administrator, the Comptroller General of the United States or any of their authorized representatives' access to any books, documents, papers and records of the Contractor which are directly pertinent to this contract for the purposes of making audits, examinations, excerpts and transcriptions. Contractor also agrees, pursuant to 49 C. F. R. 633.17 to provide the FTA Administrator or his authorized representatives including any PMO Contractor access to Contractor's records and construction sites pertaining to a major capital project, defined at 49 U.S.C. 5302(a)1, which is receiving federal financial assistance through the programs described at 49 U.S.C. 5307, 5309 or 5311. By definition, a major capital project excludes contracts of less than the simplified acquisition threshold. The Contractor agrees to permit any of the foregoing parties to reproduce by any means whatsoever or to copy excerpts and transcriptions as reasonably needed.

**2. ACCESS REQUIREMENTS FOR INDIVIDUALS WITH DISABILITIES**

The Contractor agrees to comply with all applicable requirements of the Americans with Disabilities Act of 1990 (ADA), 42 U.S.C. Section 12101 et seq. And 49 U.S.C. Section 322; Section 504 of the Rehabilitation Act of 1973, as amended, 29 U.S.C. Section 794; Section 16 of the Federal Transit Act, as amended, 49 U.S.C. App. Section 1612; and implementing regulations, as may be amended

**3. CERTIFICATION REGARDING DEBARMENT, SUSPENSION, AND OTHER RESPONSIBILITY MATTERS – Lower Tier Covered Transactions (Third Party Contracts over \$100,000)**

- a) By signing and submitting this bid or proposal, the prospective lower tier participant is providing the signed certification set out below.
- b) The certification in this clause is a material representation of fact upon which reliance was placed when this transaction was entered into. If it is later determined that the prospective lower tier participant knowingly rendered an erroneous certification, in addition to other remedies available to the Federal Government, the Department may pursue available remedies, including suspension and/or debarment.
- c) The prospective lower tier participant shall provide immediate written notice to the Department if at any time the prospective lower tier participant learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.
- d) The terms "covered transaction," "debarred," "suspended," "ineligible," "lower tier covered



transaction,” “participant,” “persons,” “principal,” “proposal,” and “voluntarily excluded,” as used in this clause, have the meanings set out in the Definitions and Coverage sections of rules implementing Executive Order 12549 [49 CFR Part 29]. You may contact the Department for assistance in obtaining a copy of those regulations.

- e) The prospective lower tier participant agrees by submitting this proposal that, should the proposed covered transaction be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction, unless authorized in writing by the Department.
- f) The prospective lower tier participant further agrees by submitting this proposal that it will include the clause “Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion - Lower Tier Covered Transaction”, without modification, in all lower tier covered transactions.
- g) A participant in a covered transaction may rely upon a certification of a prospective participant in a lower tier covered transaction that it is not debarred, suspended, ineligible, or voluntarily excluded from the covered transaction, unless it knows that the certification is erroneous. A participant may decide the method and frequency by which it determines the eligibility of its principals. Each participant may, but is not required to, check the No procurement List issued by the U. S. General Service Administration.
- h) Nothing contained in the foregoing shall be construed to require establishment of system of records in order to render in good faith the certification required by this clause. The knowledge and information of a participant is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.
- i) Except for transactions authorized under Paragraph E of these instructions, if a participant in a covered transaction knowingly enters into a lower tier covered transaction with a person who is suspended, debarred, ineligible or voluntarily excluded from participation in this transaction, in addition to all remedies available to the Federal Government, the Department may pursue available remedies including suspension and/or debarment.
- j) The prospective lower tier participant certifies, by submission of this bid or proposal, that neither it nor its “principals” [as defined at 49 CFR §29.105(p)] is presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this transaction by any Federal department or agency.
- k) When the prospective lower tier participant is unable to certify to the statements in this certification, such prospective participant shall attach an explanation to this proposal.

#### **4. CLEAN WATER REQUIREMENTS**

The Contractor agrees to comply with all applicable standards, orders or regulations issued pursuant to the Federal Water Pollution Control Act, as amended, 33 U.S.C. 1251 et seq. The Contractor agrees to report each violation to the Department and understands and agrees that the Department will, in turn, report each violation as required to assure notification to FTA and the appropriate EPA Regional Office. (2)The Contractor also agrees to include these requirements in

each subcontract exceeding \$100,000 financed in whole or in part with Federal assistance provided by FTA.

**5. FEDERAL CHANGES**

Contractor shall at all times comply with all applicable FTA regulations, policies, procedures and directives, including without limitation those listed directly or by reference in the [Master Agreement](#) between the Department and FTA, as they may be amended or promulgated from time to time during the term of this contract. Contractor's failure to so comply shall constitute a material breach of this contract.

**6. CLEAN AIR**

(1) The Contractor agrees to comply with all applicable standards, orders or regulations issued pursuant to the Clean Air Act, as amended, 42 U.S.C. §§ 7401 et seq . The Contractor agrees to report each violation to the Department and understands and agrees that the Department will, in turn, report each violation as required to assure notification to FTA and the appropriate EPA Regional Office. (2) The Contractor also agrees to include these requirements in each subcontract exceeding \$100,000 financed in whole or in part with Federal assistance provided by FTA.

**7. ENERGY CONSERVATION**

The Contractor shall recognize mandatory standards and policies relating to energy efficiency which are contained in the State Energy Conservation Plan issued in compliance with the Energy Policy and Conservation Act (42 US Section 321 et seq.).

**8. CONTRACT TERMINATION**

a) Termination for Convenience

The Department may terminate this contract, in whole or in part, at any time by written notice to the Contractor. The Contractor shall be paid its costs, including contract close-out costs, and profit on product delivered up to the time of termination. The Contractor shall promptly submit its termination claim for payment. If the Contractor has any property in its possession belonging to the Department, the Contractor will account for the same and dispose of it in the manner the Department directs.

b) Termination for Default

If the Contractor does not deliver supplies in accordance with the contract delivery schedule, or, if the contract is for services, the Contractor fails to perform in the manner called for in the contract, or if the Contractor fails to comply with any other provisions of the contract, the Department may terminate this contract for default. Termination shall be affected by serving a notice of termination on the Contractor setting forth the manner in which the Contractor is in default. The Contractor will only be paid the contract price for supplies delivered and accepted, or services performed in accordance with the manner of performance set forth in the contract.

If it is later determined that the Contractor had an excusable reason for not performing, such as a strike, flood, events which are not the fault of or are beyond the control of the Contractor, the Department, after setting up a new delivery or performance schedule, may allow the Contractor to continue work, or treat the termination as a termination of convenience.

In the event the Department exercises its right of termination for default, and if an amount for

liquidated damages is set forth, the Contractor shall be liable to the Department for excess costs and, in addition, for liquidated damages in the amount set forth, as fixed, agreed, and liquidated damages for each calendar day of delay, until such time as the Department may reasonably obtain delivery or performance of similar supplies or services.

If the contract is so terminated, the Contractor shall continue performance and be liable to the Department for such liquidated damages for each calendar day of delay until the supplies are delivered or services performed.

The Contractor shall not be liable for liquidated damages resulting from delays such as acts of God, strikes, fire or flood, and events which are not the fault of, or are beyond the control of the Contractor.

## 9. CIVIL RIGHTS

(1) Nondiscrimination - In accordance with Title VI of the Civil Rights Act, as amended, 42 U.S.C. § 2000d, section 303 of the Age Discrimination Act of 1975, as amended, 42 U.S.C. § 6102, section 202 of the Americans with Disabilities Act of 1990, 42 U.S.C. § 12132, and Federal transit law at 49 U.S.C. § 5332, the Contractor agrees that it will not discriminate against any employee or applicant for employment because of race, color, creed, national origin, sex, age, or disability. In addition, the Contractor agrees to comply with applicable Federal implementing regulations and other implementing requirements FTA may issue.

(2) Equal Employment Opportunity - The following equal employment opportunity requirements apply to the underlying contract:

The Contractor shall report violations

to the FTA.

**12. EQUAL EMPLOYMENT OPPORTUNITY**

In connection with the execution of this contract, the Contractor shall not discriminate against any employee or applicant for employment because of race, creed, religion, color, national origin, age, sex or disability. The Contractor shall take affirmative action to insure that applicants are employed, and that employees are tested during their employment without regard to their race, creed, religion, color, national origin, age, sex or disability. Such actions shall include, but not be limited to the following, employment, upgrading, demotion, or transfer, recruitment or recruitment advertising, layoff or termination; rates of pay, or other forms of compensation. The Contractor further agrees to insert a similar provision in all subcontracts, except subcontracts for standard commercial supplies or raw materials.

**13. FTA FUNDING REQUIREMENTS**

This project may be financed in part by funds from the Federal Transit Administration. Contractor shall at all times comply with all applicable FTA regulations, policies, procedures and directives, including without limitation those listed directly or by reference in the Master Agreement between the Department and FTA, as they may be amended or promulgated from time to time during the term of this contract. Contractor's failure to so comply shall constitute a material breach of this contract.

**14. INCORPORATION OF FEDERAL TRANSIT ADMINISTRATION (FTA) TERMS**

The preceding provisions include, in part, certain Standard Terms and Conditions required by DOT, whether or not expressly set forth in the preceding contract provisions. All contractual provisions required by FTA, as set forth in FTA Circular 4220.1F are hereby incorporated by reference. Anything to the contrary herein notwithstanding, all FTA mandated terms shall be deemed to control in the event of a conflict with other provisions contained in this Agreement. The Contractor shall not perform any act, fail to perform any act, or refuse to comply with any Department requests which would cause the Department to be in violation of the FTA terms and conditions.

**15. LOBBYING:**

The Contractor agrees to maintain all books, records, accounts and reports required under this contract for a period of not less than three years after the date of termination or expiration of this contract, except in the event of litigation or settlement of claims arising from the performance of this contract, in which case Contractor agrees to maintain same until the Department, the FTA Administrator, the Comptroller General, or any of their duly authorized representatives, have disposed of all such litigation, appeals, claims or exceptions related thereto. Reference 49 CFR 18.39(i)(11).

**20. SEISMIC SAFETY**

The contractor agrees that any new building or addition to an existing building will be designed and constructed in accordance with the standards for Seismic Safety required in Department of Transportation Seismic Safety Regulations 49 CFR Part 41 and will certify to compliance to the extent required by the regulation. The contractor also agrees to ensure that all work performed under this contract including work performed by a subcontractor is in compliance with the standards required by the Seismic Safety Regulations and the certification of compliance issued on the project.

**21. TITLE VI COMPLIANCE**

During the performance of any Contract entered into pursuant to these specifications, the Contractor, for itself, its assignees and successor in interest, agrees that it shall comply with Title VI of the Civil Rights Act of 1964 (42 U.S.C. section 2000d) and the Regulations relative to nondiscrimination in federally assisted programs of the Department of Transportation, Title 49, Code of Federal Regulations Part 21, as they may be amended from time to time which are incorporated by reference and made a part of this contract.

**22. INTELLIGENT TRANSPORTATION SYSTEMS**

Intelligent transportation system (ITS) property and services must comply with the National ITS Architecture and Standards to the extent required by Section 5307(c) of SAFETEA-LU, FTA Notice, "FTA National ITS Architecture Policy on Transit Projects," 66 FR 1455 et seq., January 8, 2001, and later published policies or implementing directives FTA may issue. Consequently, third party contracts involving ITS are likely to require provisions to ensure compliance with Federal requirements.
