SPECIFICATIONS

DESCRIPTION. This Agreement is for Superpave patching material supply only.

MATERIALS. The materials used for this item shall meet the applicable specifications for:

401029 – Superpave Type C, PG 64-22, Patching

401030 – Superpave Type B, PG 64-22, Patching

Sections 1012 and 1014

METHOD OF MEASUREMENT. The quantity of material to be paid for shall be the number of units of material conforming with all the requirements, furnished in accordance with these provisions.

Where applicable, weights will only be accepted as showing the actual amount of material delivered if verified by certified and stamped weight slips signed by a certified weigh master.

BASIS OF PAYMENT. The material will be paid for at the unit prices as contained in the contract, which price and payment shall constitute full compensation for furnishing the materials in accordance with these provisions. Delivery charges, if any, will be paid separately.

If material specifications are not met, the Engineer has the right to accept the material at a pro-rated payment per item 401699. The method for determining payment will be based upon the review of the test results and determining the amount from the specification tolerance the material property is.
