PUBLIC-PRIVATE PARTNERSHIP for DOVER TRANSIT CENTER Kent County

An Informational Meeting will be held in the Farmington/Felton Room of the DelDOT Administration Center, 800 Bay Road, Dover, Delaware, 19901 at 10:30 AM Local Time on Thursday, November 18, 2010 to discuss the project and the RCPQ/RFP procurement procedure. Interested submitters, subcontractors, and suppliers are encouraged to attend.

The Delaware Department of Transportation (Department) is proceeding with plans for the design and construction for a new office building at the new intermodal transit center on the City of Dover using a procedure authorized in Title 2 DelCode Chapter 20, Public-Private Initiatives Program in Transportation, more commonly referred to as Public-Private Partnerships (P3). The multi-modal Dover Transit Center is located at the intersection of Water and Queen Streets in Dover. Project includes a 30,000 square foot building; first floor passenger waiting area with restrooms, ticketing, and vending machines, remainder of the building leasable to multiple tenants. A conceptual plan for the building was developed, but will need refinement and completion by the successful Proposer. The Department's intent for this project is a Design-Build-Finance-Operate-Maintain (DBFOM) through a Comprehensive Development Agreement.

- 1. Request for Concept Proposals and Qualifications that determines the Short-List of up to three teams; and
- 2. Request for Proposals (RFP) from the Short-Listed firms.

Request for Concept Proposals and Qualifications will be available November 1, 2010. The Department will evaluate all PQSs it receives in response to this Request for Conceptual Proposals and Qualifications (RCPQ) and make a determination, in its sole discretion, whether to issue a Request for Detailed Proposals (RFP). Final selection and award of the contract, if pursued, is expected to occur summer 2011. It is the Department's intent to short-list up to three (3) firms.

The Department of Transportation hereby notifies all submitters that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, creed, color, sex, or national origin in consideration for an award.

The Submitter is responsible to disclose all potential organizational conflicts of interest in its PQS. A potential organizational conflict of interest occurs when consultants and/or subcontractors assisted the Department in the preparations of this RCPQ or the RFP document.

When it is in the best interest of the State, DelDOT may extend the time and place for the submittal of PQSs from that described above, on not less than two calendar days' notice by certified delivery, facsimile transmission, or by other verifiable electronic means to those bidders who obtained copies of the RCPQ.
