Bidder bears the risk of late delivery or delivery at any wrong or other location of the University other than specified in the ITB document. Any bid received after the stated time and place will not be entertained. The outer envelope should clearly indicate: "**Building Supplies - Contract No. 19-09-19-15 – Bid opening date and time.**"

**There will be NO mandatory pre-bid meeting.**

**Bid bond requirement for this ITB has been waived.**

**The University reserves the right to award this contract to one or more vendors. Vendors are not required to submit a price on all items in order to be considered for award.**

The term of the contract between the successful bidder and the University shall be for **three (3) years**. There is an **option** to renew the contract for **two (2) one year extensions by negotiations**. The University reserves the right to reject any or all bids in whole or in part, to make partial awards, to award to multiple vendors during the same period, to award by types, on a zone-by-zone basis or on an item-by-item or lump sum basis item by item, or lump sum total, whichever may be most advantageous to the University.

Bidders will not be subject to discrimination on the basis of race, creed, color, sex, sexual orientation, gender identity or national origin in consideration of this award, and Minority Business Enterprises, Disadvantaged Business Enterprises, Women-Owned Business Enterprises and Veteran-Owned Business Enterprises will be afforded full opportunity to submit bids on this contract. Delaware State University reserves the right to reject any or all bids and to waive any informalities therein.
