Questions and Answers

The work/ clarification/ answers listed in this addenda shall be considered part of the Bid/ RFP document for the referenced project/ product/ services, etc.

Below are questions and answers regarding subject RFP. All questions are written in black color font and the answers are provided in red color font.

Question: Could the University please share its present assumptions regarding future enrollment and resident student population?

Answer: Future enrollment and resident student population discussion will be held post RFP award.

Question: Since this is a master plan update, will the University release the entire 2014 Master Plan with appendices, or will it only share the Executive Summary?

Answer: Existing Master Plan will be shared once the project is awarded.

Question: Does DSU provide landscape maintenance in-house or is it contracted out?

Answer: Landscaping is currently contracted out.

Question: Are there any areas within the campus landscape that have cause for concerns or issues with Facilities Management?

Answer: There are currently no concerns, but this specific area can be discussed during programming.

Question: Are there sufficient outdoor spaces for students; plazas, seating areas, gathering spaces?

Answer: The new revised Master Plan will need to account for student growth and making sure that these particular areas are accounted for.

Question: Does DSU have a Landscape Maintenance and Management Plan in-place?

Answer: Yes

Question: Does DSU have a Landscape Plant Inventory Plan for the campus?

Answer: this information can be gathered through the Landscape contractor once awarded.

Question: If not, does DSU think there is a need for one with this MP update

Answer: Yes, and this will be also discussed post RFP award.

Question: Is the current campus parking adequate?

Answer: No, and we will discuss post RFP award.

Question: Is the University's existing space inventory up-to-date, or should this be included as part of our scope of work?

Answer: No, and we will discuss post RFP award.

Question: While The Evaluation Criteria lists: "Fees and other costs" as a criterium for consideration, I don't see it identified as a component to be included in our submittal. Is that correct?

Answer: "Fees and other costs" will not be part in the evaluation criteria See above clarification

Question: Is signage and wayfinding to be included in the scope?

Answer: This will be handled during programming.

Question: How many buildings are at the main campus, and what is the total square footage?

Answer: There's approximately 40 buildings and a total 1,921,000 Sq/Ft

Question: Will the satellite campuses be included in the scope of work? If so, how many buildings are on these campuses, and what is the total square footage of each campus?

Answer: Yes, 11 buildings and approximate total square footage of 337,300.

Question: Does DSU have plans of all of the structures? How many of the plans are in electronic format?

Answer: We have both, electronic and paper drawings for the existing buildings and will be provided once the project is awarded.

Question: Are the campus site plans accurate and up to date (including the satellite campuses, if part of the SOW)?

Answer: Campus site plan is 90% accurate and DSU is in progress of finalizing the deliverables.

Question: Page 38 of the RFP mentions the University wide Strategic Plan. I assume this is available on the website. Are there other documents that can provide background information on the current and projected academic programs, enrollments, etc.?

Answer: The University strategic plan will be shared once the project is awarded.

Question: How does DSU manage classroom scheduling? What software does it use?

Answer: To be provided to the awarded contractor.

Question: Does the university have an energy management plan?

Answer: Yes and will be discussed post award.

Question: Can you provide a copy of the 2014 Master Plan Update Study?
