- Addendum No. 1:
 - Clarifications: Pre-Bid meeting minutes Item 1.05: As stated in the pre-bid meeting, the only Bid Form to be is the one provided in the Project Manual. However, by virtue of the Addendum, the Bid form was substituted with a revised form as indicated in Addendum No. 1, Project Manual Changes: Item 2; Delete Bid Form in its entirety (meaning the form provided in the Manual), and substitute the revised Bid From. This means to used only the most recent Form provided, thus the Addendum No. 1 form, unless it is revised again.
