A. GENERAL

A-1	The fire alarm system work is included in the contract drawings and the bid is under the
	electrical contract. The work includes extension and modifications to the existing system.

B. BIDDER QUESTIONS & CLARIFICATIONS

Item No.	Question/Answer:
B-1	Q: There are four (4) roof penetrations, the curbs that are called out will not work with the existing roof sheets, can the duct work go through the masonry wall not the roof? ANSWER: Duct work is not to go through the masonry; provide roof curbs where noted with new curbs to accommodate the existing conditions as required.
B-2	Q: There is some type of foam sprayed on the roof panels, can information be provided on foam system? ANSWER: There is no information available on the existing foam material on the roof; the roof material has been tested by the owner and no asbestos is known to be present in the foam material; any abatement required will be performed by owner.
B-3	Q: Door C101.2 is 2" below finish floor, please advise. ANSWER: Refer to ASK-01 for required modifications to Door C101.2; refer to civil drawings 1 of 4, 2 of 4, 3 of 4 and 4 of 4 for required grade modifications associated with Door C101.2.
B-4	Q: Please confirm there are no liquidated damages. ANSWER: Liquidated damages are not applicable for this project.
B-5	Q: Please confirm that the contractor is not responsible for CAD updates. ANSWER: The contractor is not responsible to provide CAD drawings, however as-built drawings are required.
B-6	Q: Please confirm that testing services will be provided by the owner. ANSWER: No testing will be provided by owner.
B-7	Q: Spec section 072100 – Thermal Insulation refers to spray-applied cellulosic insulation. Please confirm that there is no spray insulation required for this project. ANSWER: Spray insulation is required as noted on Drawing A102 for Multi-Craft Lab 107, Heavy Equipment Lab 108 and Diesel Lab 109; these areas are noted to receive EXP and the Ceiling Legend identifies EXP as "Exposed painted with acoustic thermal spray-on material.
B-8	Q: Please provide a spec or model information for the pass thru window, see section A-A on 7/A103 ANSWER: Basis of design product to be: CRL Satin Anodized Horizontal Sliding Daisy Model Pass-thru Assembly with D6 Overhead Track without Jambs with 3/16" clear tempered glazing.
B-9	Q: The door schedule on A201 shows opening 100 to receive an aluminum frame with a steel door. This is unusual, please confirm that this is what is wanted. ANSWER: Door 100 to be aluminum.
B-10	Q: 2/A102 shows Entrance 100 receiving VCT and walk-off carpet. Please clarify. ANSWER: Entrance 100 to receive both materials as identified on 2/A102; C-2 extent is as shown, noted and dimensioned; the remainder is VCT as identified.

	Please confirm that none is required.		
	ANSWER: No demolition of mechanical units or plumbing fixtures is required.		
B-12	Q: 2/E111 shows new cameras. Please confirm that the contractor owns roughing-in for the		
	cameras, and that the owner will provide the cameras themselves.		
	ANSWER: The contractor is to provide all rough-ins / infrastructure for cameras and the		
	owner is to provide the cameras.		
B-13	Q: For those who purchases plans is it possible to get a set of the plans electronically?		
	ANSWER: All documents are available through RCI; an electronic conform set of		
	documents will be provided to the successful general contractor.		
B-14	Q: Is one bid form acceptable to submit on bid day?		
	ANSWER: Provide one original bid form and one copy.		
B-15	Q: Are there any liquidated damages on this project?		
	ANSWER: Liquidated damages are not applicable for this project.
