B. Key topics

- 1. Bids

 - b. Each bidder shall include in their bid a copy of a valid Delaware Business License.
 - c. Each bidder shall include signed Affidavit(s) for the Bidder and each listed Subcontractor certifying compliance with OMB Regulation 4104 "Regulations for the Drug Testing of Contractor and Subcontractor Employees Working on "Large Public Works Projects."
 "Large Public Works" is based upon the current threshold required for bidding Public Works as set by the Purchasing and Contracting Advisory Council.
 - d. Make sure you identify the project name and number on the front of your envelope when you submit your bid.
- 2. Building Access
 - a. A walk thru will be conducted on November 6, 2019 after today's pre-bid meeting.
- 3. Clarifications

- c. The General Contractor who is bidding the project shall have a full time superintendent or working foreman.
- d. This is a Delaware Prevailing Wage project (Kent County).
- e. Work hours are 8:00 a.m. to 4:30 p.m.
- C. Subcontractor Listing
 - 1. There are now (2) subcontractor listings on this project: Mechanical and Electrical. These Subcontractors are identified on the attached bid form.
 - 2. Be sure to list your company name if your company is performing this work.
 - 3. All companies listed must be registered in the State of Delaware to perform this work.
 - 4. Controls Contractor: DTCC uses CM3 for building automation. The proposed work on the documents have been provided to CM3 and CM3 has provided a budget price of \$15,500 for the Base Bid and \$9,500 for the Alternate #1 work. The successful contractor shall utilize CM3 as a subcontractor and shall pay for their service thru Allowance #1.
- D. Allowances
 - 1. There are (2) allowances on this project that shall be included in the base bid. \$25,000 to cover controls work associated with this project. \$10,000 to cover miscellaneous items found during construction.
- E. Meetings
 - 1. There will be progress meetings on this project every 2 weeks on a specific day and time, to be determined at the kick off meeting.
 - 2. Contractors shall provide 3 week look ahead schedule at each meeting to indicate work areas and shut downs.
