The attached Definitions and General Provisions apply to all contracts and are part of each invitation to bid. The requirement to furnish a bid bond and performance bond is applicable unless waived in the Special Provisions. Should the General Provisions conflict with the Special Provisions, the Special Provisions shall prevail. Bidders or their authorized representatives are required to fully acquaint themselves as to State procurement laws and regulations prior to submitting bid.

DEFINITIONS

Whenever the following terms are used, their intent and meaning shall be interpreted as follows:

STATE: The State of Delaware

AGENCY: State Agency as noted on cover sheet.

DESIGNATED OFFICIAL: The agent authorized to act for the Agency.

BID INVITATION: The "bid invitation" or "invitation to bid" is a packet of material sent to vendors and consists of General Provisions, Special Provisions, specifications, and enclosures.

GENERAL PROVISIONS: General Provisions are instructions pertaining to contracts in general. They contain, in summary, requirements of laws of the State, policies of the Agency, and instructions to vendors.

SPECIAL PROVISIONS: Special Provisions are specific conditions or requirements peculiar to the contract under consideration and are supplemental to the General Provisions. Should the Special Provisions conflict with the General Provisions, the Special Provisions shall prevail.

BIDDER OR VENDOR: Any individual, firm, or corporation formally submitting a proposal for the material or work contemplated, acting directly or through a duly authorized representative.

PROPOSAL: The offer of the bidder submitted on the approved form and setting forth the bidder's prices for performing the work or supplying the material or equipment described in the specifications.

SURETY: The corporate body which is bound with and for the contract, or which is liable, and which engages to be responsible for the contractor's payments of all debts pertaining to and for its acceptable performance of the work for which it has contracted.

BIDDER'S DEPOSIT: The security designated in the proposal to be furnished by the bidder as a guaranty of good faith to enter into a contract with the Agency if the work to be performed or the material or equipment to be furnished is awarded to the bidder.

CONTRACT: The written agreement covering the furnishing and delivery of material or work to be performed.

CONTRACTOR: Any individual, firm, or corporation with whom a contract is made by the Agency.

CONTRACT BOND: The approved form of security furnished by the contractors and its surety as a guaranty of good faith on the part of the contractor to execute the work in accordance with the terms of the contract.

SECTION A - GENERAL PROVISIONS

1. **BID INVITATION:**

See "Definitions".

2. **PROPOSAL FORMS:**

The invitation to bid shall contain pre-printed forms for use by the vendor in submitting its bid. The forms shall contain basic information such as description of the item and the estimated quantities and shall have blank spaces for use by the vendor for entering information such as unit bid price, total bid price, etc.

3. **INTERPRETATION OF ESTIMATES:**

- a. The attention of bidders is called to the fact that, unless stated otherwise, the quantities given in the proposal form are to be considered to be approximate only and are given as a basis for the comparison of bids. The Agency may increase or decrease the amount of any item as may be deemed necessary or expedient, during the period of the contract.
- b. An increase or decrease in the quantity for any item is not sufficient ground for an increase or decrease in the unit price.

4. **SILENCE OF SPECIFICATIONS:**

The apparent silence of the specifications as to any detail, or the apparent omission from it of detailed description concerning any point, shall be regarded as meaning that only the best commercial practice is to prevail and only material and workmanship of the first quality are to be used. Proof of specifications compliance will be the responsibility of the vendor.

5. **EXAMINATION OF SPECIFICATIONS AND PROVISIONS:**

The bidder shall examine carefully the proposal and the contract forms for the material contemplated. The bidder shall investigate and satisfy itself as to the conditions to be encountered, quality and quantities of the material to be furnished, and the requirements of the Special Provisions and the contract. The submission of a proposal shall be conclusive evidence that the bidder has made examination of the aforementioned conditions.

6. **PREPARATION OF PROPOSAL:**

- a. The bidder's proposal shall be written in ink or typewritten on the form provided.
- b. If items are listed with a zero quantity, bidder shall state unit price **ONLY** (intended for open end purchases where estimated requirements are not known). The proposal shall show a total bid price for each item bid and the total bid price of the proposal excluding zero quantity items.

7. **PRICES QUOTED:**

The prices quoted are those for which the material will be furnished F.O.B. Ordering Agency and include all charges that may be imposed during the period of the contract.

8. **DISCOUNT:**

No qualifying letter or statements in or attached to the proposal, or separate discounts will be considered in determining the low bid except as may be otherwise herein noted. Cash or separate discounts should be computed and incorporated into unit bid price(s).

9. **SAMPLES OR BROCHURES:**

Samples or brochures may be required by the agency for evaluation purposes. They shall be such as to permit the Agency to compare and determine if the item offered complies with the intent of the specifications.

10. **PROPOSAL GUARANTY; BID BOND:**

- a. Each bidder shall submit with its proposal a guaranty in sum equal to at least 10% of the total value of its bid, according to Delaware Code Title 29, Section 6927(a).
- b. This bid bond shall be submitted in the form of good and sufficient bond drawn upon an insurance or bonding company authorized to do business in the State of Delaware, to the State of Delaware for the benefit of the Agency, or a certified check drawn on a reputable banking institution and made payable to the Agency in the requirement amount. If Agency bond form is not utilized, the substituted bond forms must conform to the minimum of conditions specified in the Agency bond form.

11. **DELIVERY OF PROPOSALS:**

Proposals shall be delivered in sealed envelopes, and shall bear on the outside the name and address of the bidder as well as the designation of the contract. Proposals forwarded by U.S. Mail shall be sent first class to the address listed below. Proposals forwarded by delivery service other than the U.S. Mail or hand delivered must be delivered to the address listed below. All bids must clearly display the bid number on the envelope.

All proposals will be accepted at the time and place set in the advertisement. Bidder bears the risk of delays in delivery. Proposals received after the time set for public opening will be returned unopened.

12. **WITHDRAWAL OF PROPOSALS:**

A bidder may withdraw its proposal unopened after it has been deposited, if such a request is made prior to the time set for the opening of the proposal.

13. **PUBLIC OPENING OF PROPOSALS:**

The bids shall be publicly opened at the time and place specified by the Agency. Bidders or their authorized representatives are invited to be present.

14. **PUBLIC INSPECTION OF PROPOSALS:**

If the bidder designates a portion of its bid as confidential, it shall isolate and identify in writing the confidential portions. The bidder shall include with this designation a statement that explains and supports the firm's claim that the bid items identified as confidential contain trade secrets or other proprietary data.

15. **DISQUALIFICATION OF BIDDERS:**

Any one or more of the following causes may be considered as sufficient for the disqualification of a bidder and the rejection of its proposal or proposals:

- a. More than one proposal for the same contract from an individual, firm, or corporation under the same or different names.
- b. Evidence of collusion among bidders.
- c. Unsatisfactory performance record as evidenced by past experience.
- d. If the unit prices are obviously unbalanced either in excess or below reasonable cost analysis values.
- e. If there are any unauthorized additions, interlineation, conditional or alternate bids or irregularities of any kind which may tend to make the proposal incomplete, indefinite, or ambiguous as to its meaning.
- f. Non-attendance of mandatory pre-bid meetings may be cause of disqualification.

SECTION B - AWARD AND EXECUTION OF CONTRACT

1. **CONSIDERATION OF BIDS:**

- a. After the proposals have been opened, the bids will be tabulated and the results will be made available to the public. Tabulations of the bids will be based on the correct summation of items at the unit price bid.
- b. The right is reserved to waive technicalities, to reject any or all bids, or any portion thereof, to advertise for new proposals, to proceed to do the work otherwise, or to abandon the work, if in the judgment of the Agency or its agent, the best interest of the State will be promoted thereby.

2. **MATERIAL GUARANTY:**

Before any contract is awarded, the successful bidder may be required to furnish a complete statement of the origin, composition and manufacture of any or all of the material to be used in the contract together with such samples as may be requested for the purpose of testing.

3. **CONTRACT AWARD:**

Within thirty days from the date of opening proposals, the contract will be awarded or the proposals rejected.

4. **EXECUTION OF CONTRACT:**

- a. The bidder to whom the award is made shall execute a formal contract and bond within twenty days after date of official notice of the award of the contract.
- b. If the successful bidder fails to execute the required contract and bond, as aforesaid, within twenty days after the date of official notice of the award of the contract, its proposal guaranty shall immediately become forfeited as liquidated damages. Award will then be made to the next lowest qualified bidder of the work or re-advertised, as the Agency may decide.

5. **REQUIREMENT OF CONTRACT BOND:**

- a. Successful bidders shall furnish bond, simultaneously with the execution of the formal contract, to the State of Delaware for the benefit of the Agency with surety in the amount of 100% of the total contract award or as otherwise provided in the Special Provisions. Said bonds shall be conditioned upon the faithful performance of the contract.
- b. The bond forms shall be provided by the Agency and the surety shall be acceptable to the Agency.

6. **WARRANTY:**

The successful bidder(s) shall be required to extend any policy guarantee usually offered to the general public, FEDERAL, STATE, COUNTY, or MUNICIPAL governments, on material in this contract against defective material, workmanship, and performance.

7. **THE CONTRACT(S):**

The contract(s) with the successful bidder(s) will be executed with the Office of Management and Budget, Government Support Services section acting for all participating agencies.

8. **RETURN OF BIDDER'S DEPOSIT:**

The deposits shall be returned to the successful bidder upon the execution of the formal contract. The deposits of unsuccessful bidders shall be returned to them immediately upon the awarding of the contract or rejection of their bids.

9. **INFORMATION REQUIREMENT:**

The successful bidder's shall be required to advise the Office of Management and Budget, Government Support Services of the gross amount of purchases made as a result of the contract.

10. **CONTRACT EXTENSION:**

The State reserves the right to extend this contract on a month-to-month basis for a period of up to three months.

11. **TERMINATION FOR CONVENIENCE:**

Contracts shall remain in effect for the time period and quantity specified unless the contract is terminated by the State. The State may terminate the contract at any time by giving written notice of such termination and specifying the effective date thereof, at least sixty (60) days before the effective date of termination.

12. **TERMINATION FOR CAUSE:**

If, for any reasons, or through any cause, the Contractor fails to fulfill in timely and proper manner its obligations under this Contract, or if the Contractor violates any of the covenants, agreements, or stipulations of this Contract, the State shall thereupon have the right to terminate this contract by giving written notice to the Contractor of such termination and specifying the effective date thereof, at least 5 days before the effective date of such termination. In that event, all finished or unfinished documents, data, studies, surveys, drawings, maps, models, photographs, and reports or other material prepared by the Contractor under this Contract shall, at the option of the State, become its property, and the Contractor shall be entitled to receive just and equitable compensation for any satisfactory work completed on such documents and other materials which is usable to the State.

SECTION C - GENERAL

1. **AUTHORITY OF AGENCY:**

On all questions concerning the interpretation of specifications, the acceptability and quality of material furnished and/or work performed, the classification of material, the execution of the work, and the determination of payment due or to become due, the decision of the Agency shall be final and binding.

2. **LAWS TO BE OBSERVED:**

The contractor is presumed to know and shall strictly comply with all National, State, or County laws, and City or Town ordinances and regulations in any manner affecting the conduct of the work. The contractor shall indemnify and save harmless the State of Delaware, the Agency, and all Officers, Agency and Servants thereof against any claim or liability arising from or based upon the violation of any such laws, ordinances, regulations, orders, or decrees whether by itself or by its employees.

3. **PERMITS AND LICENSES:**

All necessary permits, licenses, insurance policies, etc. required by local, State or Federal laws, shall be provided by the contractor at its own expense.

4. **PATENTED DEVICES, MATERIAL AND PROCESSES:**

- a. The contractor shall provide for the use of any patented design, device, material, or process to be used or furnished under this contract by suitable legal agreement with the patentee or owner, and shall file a copy of this agreement with the Agency.
- b. The contractor and the surety shall hold and save harmless the State of Delaware, the Agency, the Director, their Officers or Agents from any and all claims because of the use of such patented design, device, material, or process in connection with the work agreed to be performed under this contract.

5. **EMERGENCY TERMINATION OF CONTRACT:**

- a. Due to restrictions which may be established by the United States Government on material, or work, a contract may be terminated by the cancellation of all or portions of the contract.
- b. In the event the contractor is unable to obtain the material required to complete the items of work included in the contract because of restrictions established by the United States Government and if, in the opinion of the Agency, it is impractical to substitute other available material, or the work cannot be completed within a reasonable time, the incomplete portions of the work may be cancelled, or the contract may be terminated.

6. **TAX EXEMPTION:**

- a. Material covered by this proposal is exempt from all FEDERAL and STATE TAXES. Such taxes shall not be included in prices quoted.
- b. Any material which is to be incorporated in the work or any equipment required for the work contemplated in the proposal may be consigned to the Agency. If the shipping papers show clearly that any such material is so consigned, the shipment will be exempt from the tax on the transportation of property under provisions of Section 3475 (b) of the Internal Revenue Code, as amended by Public Law 180 (78th Congress). All transportation charges shall be paid by the contractor. Each bidder shall take its exemption into account in calculating its bid for its work.

7. **OR EQUAL (PRODUCTS BY NAME):**

Specifications of products by name are intended to be descriptive of quality or workmanship, finish and performance. Desirable characteristics are not intended to be restrictive. Substitutions of products for those named will be considered provided the vendor certifies that the function, characteristics, performance and endurance qualities of the material offered is equal or superior to that specified.

8. **BID EVALUATION AND AWARD:**

The Office of Management and Budget, Government Support Services will award this contract to the lowest responsible bidder(s) which in their judgment best serves the interest of the State of Delaware in accordance with Delaware Code Title 29, Section 6923(k). Personnel with experience and technical background may be utilized by the Office of Management and Budget, Government Support Services in making judgment. In case of error in price extension, the unit price(s) shall prevail.

9. **INVOICING:**

After the awards are made, the agencies participating in the bid may forward their purchase orders to the successful bidder(s) in accordance with State Purchasing Procedures. The State will generate a payment voucher upon receipt of an invoice from the vendor.

SECTION D - EQUAL OPPORTUNITY

1. **EQUALITY OF EMPLOYMENT OPPORTUNITY ON PUBLIC WORKS:**

During the performance of any contract for public works financed in whole or in part by appropriation of the State of Delaware, the contractor agrees as follows:

- a. The contractor will not discriminate against any employee or applicant for employment because of race, creed, color, sex, age, or national origin. The contractor will take affirmative action to ensure that applicants are employed and that employees are treated equally during employment without regard to their race, creed, color, sex, age, or national origin. Such action shall include, but not be limited to the following: advertising, lay-off or termination, rates of pay or other forms of compensation, and selection for training including apprenticeships. The contractor agrees to post in conspicuous places, notices to be provided by the contracting agency setting forth the provisions of this non-discrimination clause.
- b. The contractor will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to race, creed, color, sex, age, or national origin.
- c. The term "contractor for public works" means construction, reconstruction, demolition, alteration, and/or repair work, maintenance work, and paid for in whole or in part out of the funds of a public body except work performed under a vocational rehabilitation program. The manufacture or furnishing of materials, articles, supplies or equipment is not a public work within the meaning of this subsection unless conducted in connection with and at the site of the public work.

SPECIAL PROVISIONS

1. **CONTRACT REQUIREMENTS:**

This contract will be issued to cover the **GSS11624-SOLARARROW** requirements for all State Agencies and shall be accessible to any School District, Political Subdivision, or Volunteer Fire Company.

2. **MANDATORY USE CONTRACT:**

REF: Title 29, Chapter 6911(d) Delaware Code. All Covered Agencies as defined in 29 Del. C. §6902(6) shall procure all material, equipment and nonprofessional services through the statewide contracts administered by Government Support Services, Office of Management and Budget. Delaware State University, Delaware Technical and Community College, school districts, and the Legislative Branch are specifically exempted from the requirements of this subchapter. In addition, the Delaware Transit Corporation is exempt from the entire procurement chapter. Pursuant to 29 Del. C. §6904(l) and (n) respectively, the Department of Elections and the Board of Pension Trustees have certain exemptions from the procurement chapter which may or may not apply to this Invitation to Bid.

3. **CONTRACT PERIOD:**

Each vendor's contract shall be valid upon contract execution through September 30, 2013. Each contract may be renewed for three (3) additional one year extensions through negotiation between the contractor and the Office of Management and Budget, Government Support Services. Negotiation must be initiated no later than ninety (90) days prior to the termination of the current agreement.

4. **PRICES:**

Prices shall remain firm for each term of the contract.

5. **PRICE ADJUSTMENT:**

For the second and each succeeding term, the Office of Management and Budget, Government Support Services shall have the option of offering a determined price adjustment and shall not exceed the current Philadelphia All Urban Consumers Price Index (CPI-U), U.S. City Average. If the CPI-U is used, any increase/decrease shall reflect the change during the previous published twelve (12) month period at the time of renegotiation.

The successful bidder agrees that it shall indemnify and hold the State of Delaware and all its agencies harmless from and against any and all claims for injury, loss of life, or damage to or loss of use of property caused or alleged to be caused, by acts or omissions of the successful bidder, its employees, and invitees on or about the premises and which arise out of the successful bidder's performance, or failure to perform as specified in the Agreement.

15. **OWNERSHIP OF INTELLECTUAL PROPERTY:**

All copyright and patent rights to all papers, reports, forms, materials, creations, or inventions created or developed in the performance of this contract shall become the sole property of the State of Delaware. On request, the contractor shall promptly provide an acknowledgment or assignment in a tangible form satisfactory to the State to evidence the State's sole ownership of specifically identified intellectual property created or developed in the performance of the contract.

16. **NON-PERFORMANCE:**

In the event the vendor does not fulfill its obligations under the terms and conditions of this contract, the ordering agency may purchase equivalent product on the open market. Any difference in cost between

Under no circumstances shall monies be due the vendor in the event open market products can be obtained below contract cost. Any monies charged to the vendor may be deducted from an open invoice.

17. **FORCE MAJEURE:**

Neither the vendor nor the ordering agency shall be held liable for non-performance under the terms and conditions of this contract due, but not limited to, government restriction, strike, flood, fire, or unforeseen catastrophe beyond either party's control. Each party shall notify the other in writing of any situation that may prevent performance under the terms and conditions of this contract.

18. **CONTRACTOR NON-ENTITLEMENT:**

Additionally, they shall not utilize other Central Contracts to fulfill the requirements of their respective contract as they are not a "Covered Agency" as defined by Title 29 Chapter 69 of the State Procurement Code.

19. **EXCEPTIONS:**

Bidders may elect to take minor exception to the terms and conditions of this ITB. The Office of Management and Budget, Government Support Services shall evaluate each exception according to the intent of the terms and conditions contained herein, but must reject exceptions that do not conform to State bid law and/or create inequality in the treatment of bidders. 20. **MANDATORY USAGE REPORT:**

32. **TERMINATION FOR CAUSE:**

SPECIFICATIONS

INTENT AND PURPOSE:

It is the intent and purpose of these specifications to describe a **Trailer Mounted Solar Powered Arrowboard**. All components necessary to make a complete operating unit shall be provided even if not identified in these specifications. Bidders must submit with their bid complete specifications on the unit they propose to furnish. These specifications shall indicate minimum requirements, including components, accessories and safety features considered standard. Only Department approved solar arrowboards shall be considered to bid this contract.

Prior to delivery, the unit shall be:

- a. Complete with accessories and equipment properly installed and operative.
- b. Provided with a copy of the Manufacturer's Service and Warranty Policy with all warranty certification vouchers, certifications and or coupons.

1. **ARROW PANEL:**

- 1.1 The arrow panel shall be 48" tall x 96" wide constructed of .063 sheet aluminum, minimum, painted flat black, and shall contain 15, 5" amber, minimal glare, hooded super LED lamps size Par 46.
- 1.2 The frame and vertical members of the arrow panel shall be constructed of a minimum of 3/32" x 3" x 1" aluminum channel. Corners and internal cross members shall be gusseted to provide extra strength.
- 1.3 An access panel shall be provided on the rear panel to access the internal strip if available.
- 1.4 The arrow panel shall be capable of creating the following display:
 - a. Right Arrow 10 lamps flashing in unison forming an arrow.
 - b. Left Arrow 10 lamps flashing in unison forming an arrow.
 - c. Double Arrow 5 lamps in each arrow head and 3 lamps in a common shaft all flashing in unison.
 - d. Warning/Caution 4 outermost corner lamps flashing in unison.

2. **CONTROL SYSTEM:**

- 2.1 The system shall operate an 12V DC input to the controller.
- 2.2 The lamps shall be electronically controlled by solid state microprocessor controlled circuitry. A lamp intensity regulator shall hold the lamp output constant with varying battery voltage.
- 2.3 All wire harnesses shall be made up of weather proof jacket wire/cable. All cables shall be routed to minimize chafing and interference with moving parts.

- 2.4 The controller shall be mounted in weatherproof, ventilated, lockable enclosure.
- 2.5 The system shall provide continuous monitoring of battery bank voltage with a low voltage warning and shutdown to prevent deep discharge of the batteries.
- 2.6 Upon detection of low battery bank voltage the controller shall automatically change over to a four point flash to continuously provide a caution indication to motorists.
- 2.7 The light output intensity shall be controlled by an automatic dimmer with a manual override.
- 2.8 The unit shall have an on board 110V AC/12V DC battery charger for battery charging when units are stored inside. The charger shall be overload protected to prevent over charging of the battery bank. The charger shall also have a current meter to monitor the AC charge rates.
- 2.9 Short circuit protection shall be installed to protect the lamps and the wiring harnesses.
- 2.10 A battery condition indicator and a test mode shall be provided to monitor the systems battery charge.
- 2.11 The arrow flash rate shall not be less than 30 times per minute or more than 40 times per minute.
- 2.12 The unit shall incorporate an hour meter to monitor the usage of the arrow panel. The hour meter shall be installed to only log hours of arrow use for maintenance purposes only.

3. **SIGN LIFT AND SUPPORT FRAME:**

- 3.1 The panel lift arms shall be fabricated from, as a minimum, 11 GA. x 2" square carbon steel tubing.
- 3.2 The lifting mechanism shall be a 1000lb. minimum capacity hand operated braking winch using 3/16" minimum wire cable and pulley mechanism.
- 3.3 Locking devices to secure the sign/solar panel in the raised or lowered position shall be heavy duty steel spring loaded latches or rubber bumpers.
- 3.4 The sign supporting frame shall be fabricated from 1/8" minimum wall x 2" x 2" square tubing all welded construction to complete the frame as a minimum.
- 3.5 The sign panel shall be secured to the sign support frame at four (4) locations.
- 3.6 The sign panel lifting assembly shall be locked in position by a spring loaded latch assembly or rubber bumpers during both display or travel modes.

4. **POWER SUPPLY (DC VOLTAGE):**

- 4.1 The solar generator shall incorporate a 12V DC, single crystal photovoltaic solar panel array mounted on a self-erecting, automatic positioning platform. The solar panel shall provide a maximum charge to the battery bank while exposed to the sun based on panel design.

- 4.2 The battery bank shall consist of a minimum of two (2) deep cycle, 234 AMP minimum hour 12V DC batteries, providing a minimum total storage capacity of 468 AMP hours at the 100 hour rate.
- 4.3 The battery bank shall provide sufficient capacity to power the unit for a minimum of 15 days at 28 degrees displaying one arrow, 24 hour operation, with no solar assist.
- 4.4 The batteries shall be regulated and protected by solid state microprocessor controlled electronics. A low voltage disconnect shall protect the battery bank from over discharging. A system shall be incorporated to protect the batteries from overcharge.
- 4.5 The batteries shall be housed in a ventilated, weatherproof housing. The enclosure shall have an access panel which allows the batteries to be easily removed and replaced.

5. **TRAILER:**

- 5.1 The trailer deck shall be fabricated from a minimum of 1/8" formed steel.
- 5.2 The battery box shall be constructed from a minimum of 14 gauge steel. A door support shall be provided. The batteries shall be held in place by a hold down assembly. The battery enclosure lid and access panels shall be lockable using a single latch/locking system.
- 5.3 The axle shall be 2000 pound minimum rated and equipped with roller bearings and hubs as a minimum.
- 5.4 The tires and wheels shall be a minimum of 205/75 R14 6 ply trailer tubeless mounted on steel wheels.
- 5.5 The fenders shall be constructed of a minimum of 16 gauge rolled steel.
- 5.6 The hitch shall be a 3" pintle eye that is adjustable is high from 18 to 28 inches.
- 5.7 The trailer shall be equipped with 1/4" safety chains with a 2600 lb. rated slip safety hook.
- 5.8 The trailer shall be equipped with four (4) adjustable jackstands, one mounted on each corner of the unit. The jackstands, at a minimum shall be the cranking/swing type and are telescopically designed to slide outward for a wide stance and maximum stability.
- 5.9 The trailer tongue shall be .250" thick x 2 1/2" square tubing, 60" overall length, minimum. The tongue shall be removable.
- 5.10 The trailer shall have red and white D.O.T. safety tape placed around the entire lower frame of the trailer. Reflectors shall be installed on each side, 2 amber front, 2 red at the rear. Combination marker light/stop taillight assemblies, one (1) with license plate bracket and tag light to be mounted at the rear of the trailer.

6. **PAINT:**

- 6.1 The arrow board and trailer assembly shall be painted standard manufacturer color. Paint film shall be a minimum of 4 mils thick including the prime coat.

7. **MANUALS:**

- 7.1 Operator's Repair Parts and Shop Repair Manuals or CD ROMS shall be provided for all components.
- 7.2 The manual listed shall be official O.E.M. provided for all components publications supplemented with technical manuals for all components as published by Sub-Vendors/Manufacturers.
- 7.3 An internet based technical reference which covers the major components above rear names and passwords to major components, and manufacturer's site, if available.

8. **TRAINING:**

- 8.1 The successful bidder shall arrange with the manufacturer to conduct a minimum of five (5) hours of operation, preventive maintenance, and service instruction. This instruction shall be conducted at a location to be designated by the Department within four (4) weeks after delivery of the complete unit. If required, training shall be performed at each District (up to four (4) locations). Operator training shall consist of the following at a minimum: Operator maintenance, adjustments, and how to use the full capabilities of the equipment as well as its safe and effective operation. In addition, you shall provide mechanical training on basic operation of the equipment, adjustments, preventive maintenance and repair.
- 8.2 One (1) operator training VHS videos or DVD. DVD is preferred. This operator training video shall cover operator inspection, operator minor maintenance, adjustments and how to operate equipment.
- 8.3 The successful bidder shall be contacted by the Department personnel to arrange the specific areas to be covered. However, for planning purposes, scheduled servicing, trouble shooting of the various systems and suggested preventive maintenance should be considered.
