PREADMISSION SCREENING & RESIDENT REVIEW (PASRR) SERVICES

**DELAWARE HEALTH AND SOCIAL SERVICES
DIVISION OF SUBSTANCE ABUSE AND MENTAL HEALTH**

The Division of Substance Abuse and Mental Health (DSAMH) is seeking to contract with one or more individuals to provide PASRR Services. This position is responsible for conducting evaluations of individuals who are applying for nursing home care. The goal of the PASRR process is to make a determination if an individual who may have a mental illness, can be properly supported in a nursing home facility given adequate supports and resources, or if an alternative to a nursing home is needed given the specific needs of the individual. The successful contractor will:

1. Visit clients at their residence (home, hospital, nursing home or other living facilities) in order to complete a face to face assessment;
2. Be accessible to DSAMH and Medicaid Administration/DMMA personnel daily by telephone and fax;
3. Complete assessments within seven calendar days of notification by DMMA;
4. Conduct face to face evaluations on site wherever the client is located statewide;
5. Keep Medicaid Administration/DMMA apprised of potential delays or problems;

All interested parties must be currently licensed or eligible for licensure for at least one of the following licenses/certifications in the state of Delaware:

Psychiatrist,
Licensed Clinical Social Worker (LCSW),
Advance Practice Nurse (APN),
Licensed Psychologist

In addition all interested parties must have a minimum of three years experience assessing the needs and serving individuals with severe and persistent mental illness. Experience providing these services to older individuals is preferred.

Determination of qualified applicants will be based on a review of credentials (50%), and experience (50%). An example of credentials may include but is not limited to Level of Education (Undergraduate, Graduate and Post Graduate degree), Field(s) of Study, additional certifications/training, and letters of recommendation. An example of experience may include but is not limited to the number of years working in the related field(s) and the highest level of responsibility held in the related field(s). Selection of applicant(s) will be made by the Director

of Community Mental Health and Addiction Services and the Division Director for Substance Abuse and Mental Health following the interview of one or more qualified applicants.

Any evidence of agreement or collusion among Vendor(s) and prospective Vendor(s) acting to illegally restrain freedom from competition by agreement to offer a fixed price, or otherwise, will render the offers of such Vendor(s) void.

By responding, the Vendor shall be deemed to have represented and warranted that its proposal is not made in connection with any competing Vendor submitting a separate response to this RFP, and is in all respects fair and without collusion or fraud; that the Vendor did not participate in the RFP development process and had no knowledge of the specific contents of the RFP prior to its issuance; and that no employee or official of the State of Delaware participated directly or indirectly in the Vendor's proposal preparation.

Advance knowledge of information which gives any particular Vendor advantages over any other interested Vendor(s), in advance of the opening of proposals, whether in response to advertising or an employee or representative thereof, will potentially void that particular proposal.

Resumes must be sent under cover of a brief letter of interest specifying availability, proposed annual salary and rate of reimbursement for travel within the state of Delaware. **Both the Letter of Interest and the outer mailing envelope must reference RFP HSS-13-017.** Any submission without the required information will not be reviewed. Applications will be accepted only from individual applicants. Actual service location, hours and rate of compensation is subject to negotiation.
