COMMUNITY EVALUATION TEAM (CET) Pre-Bid Meeting Questions and Answer

Q1. Should all contracts with the State be listed?

Yes, all contracts should be listed

Q2. Business proposal and technical proposals are to be separated, are the same number of copies required?

Yes, each copy of your response must include both a business proposal and a technical proposal.

Q3. Page 12, Section 2 and Page 17, number 6: "Community Data Coordinators" are discussed in this RFP (e.g., train community data coordinators). Are the Community Data Coordinators currently in place with the funded SPF-SIG contractors? Is this a role included in their contracts or is it an anticipated future role?

Currently, the CET contractors have community data coordinators assigned to each contractor. Additionally, the contractors have trained (with the help of the Evaluation team) youth and adults to collect community data. This has been a one-time event.

Q4. Page 15, Section C, 4th Bullet Point: Both CET and SEOW Contract call for a policy summit. We are assuming these are separate policy summits. Is this correct?

The policy summits should be separate activities. If it is the same contractor, discussions can be initiated to determine if two Policy Summits are the most effective approach.

Q5. Page 15, Section C: The RFP states that a primary task is to "assist community contractors with the preparation of the annual evaluation reports SPI Profile: process, results, and data gaps." Can you clarify what is meant by "EPI Profile"?

EPI Epidemiological Profile, include all of the information: process, results, data gaps

Q6. Page 17, Section E, Point 9E: I0t says "coalitions." Do you mean coalitions, contractors, or both?

It's both.

Q7. Page 17, Section E, Point 10A: What is meant by" Prevention Resource Centers"? Do they currently exist?

The resource centers do not currently exist
