- How will the RFP affect current contracts? Answer: Current contracts will not be affected as contracts are in alignment with the federal fiscal year: October 1-September 30.
- 2. For those who have grants, will there be any changes? Answer: Existing grants will not be affected.
- Is \$400,000 in funding for one year? Answer: Yes, and contingent upon federal funding.
- 4. Will the \$400,000 be for multiple vendors? Answer: Yes, the \$400,000 may be issued to multiple vendors.
- 5. If there are multiple vendors, will there be multiple contracts? Answer: There can be multiple contracts for multiple vendors.
- 6. What happens if you receive more than \$400,000 in bids, will you negotiate? Answer: Yes.
- 7. When submitting a bid, is there a bid section to specify county? Answer: Yes.
- 8. Do actual CDs have to be submitted? Answer: Yes.
- 9. Aside from compliance, what are you looking for in a vendor? Answer: What we are looking for is stated in the RFP.
- 10. Are reporting requirements different? Answer: No.
- 11. Does state ever raise salaries in the contract? Answer: Contingent upon contractor proposal.
- 12. Does state have a mentoring program to help people through a program of this scope?

Answer: You may contact the DHSS Procurement office for help.

- 13. Is there conflict with a current contractor seeking supplemental grant money? Answer: RFP contracts will be independent of any existing contracts. Therefore, requests for supplemental grant money are not be possible.
- 14. In terms of a contract, can you request subsequent money? Answer: Only through RFP budget proposal.
- 15. Where do the different contracts go? Answer: Procurement office.
- 16. Are there considerations when a contract is done? Answer: Refer to RFP.
- 17. Where does the signature sheet for this pre-bid meeting go? Answer: It is kept on file at the DHSS Procurement office.
