- 1) Who is the current incumbent lab? LabCorp
- 2) Page 2 The RFP states the Hospital will provide a Phlebotomist and then later it says that the Applicant will provide a Phlebotomist. Can this be clarified? As stated in the pre-bid meeting, the RFP should include a proposal to cover phlebotomy services either part or full time. It is possible that DPC will hire a phlebotomist but this is not certain.
- 3) Is the Phlebotomist service required on weekends? Yes
- 4) Can we get the amount of the current contract?

 The Fiscal Year 15 contract amount was \$100,000 for Delaware Psychiatric Center.
- 5) Page 3, 48 hour turn-around time, is that for initial analysis or confirmation as well?48 hours for confirmation after pickup for the majority of tests requested, for STAT draws, 5 hours after pickup.
- 6) Can we get an idea of the ordered test for the past year? (Utilization). Prior year utilization for Delaware Psychiatric Center is attached below. This information is not available for the community programs we wish to add via this RFP.
- 7) Is the billing 100% reimbursed by the State? Yes for the services provided at Delaware Psychiatric Center and for the tests ordered/performed on the uninsured clients in the community.
- 8) Can we get the schedule or Appendix H in excel format and include YTD test utilization at the individual test level?

An Excel version of Appendix H will be posted to the bids website. Prior utilization is attached below.

- 9) What are the types of test required under this RFP There is a list in Appendix H.
- 10) Can we know of the 38,000 tests from the hospital and community centers, what percentage is billed to the state and what percent is billed to a third party insurer? What types of insurances your patients have?

 See prior year utilizations below for Delaware Psychiatric Center. We do not have the information for the community programs we are adding via this RFP as each community program previously paid for the lab services themselves. In the community system, there are a high number of insured clients, primarily Medicare and Medicaid. The remaining are uninsured and would be covered by DSAMH.
- 11) What about indirect and direct technology costs? Does that include phone lines and networks?

The applicant will need to identify both its indirect and direct technology cost – if the applicant is requesting reimbursement.

- 12) Third party billing how will the billing work?

 Community programs will provide client's insurance information on the lab order slip so the third party can be billed and will indicate DSAMH as the payor for the uninsured clients.
- 13) Hardware: What is the vendor required to submit?

 The applicant is required to submit any applicable cost for hardware i.e. computers, printers etc...
- 14) Would a vendor be allowed to contract to provide urine drug testing only?

 No, the awarded contract needs to encompass the entire need specified. Please note that DSAMH has a separate contract for urine drug testing for the community programs which will not be replaced via this RFP community programs will not use the awarded vendor for urine drug testing.
- 15) Would a vendor be allowed to contract to provide services for the community mental health centers only?

The applicant's proposal should specify the proposed services and clearly identify the scope of their services.

- 16) The RFP states there is one hospital and 4 community mental health centers but at the meeting it was mentioned that there may be 6 community mental health centers. Please confirm the number of community health centers to be served under this RFP. Currently, there is one Hospital and 3 Community Mental Health Centers receiving lab services under the existing contract. Contract(s) awarded as a result of this RFP will have multiple community programs minimally, there are 15 locations throughout the state to be covered. Additional locations may be added at a later date as those programs are brought online.
- 17) The RFP states that the CMHC consumers are given lab orders and go to independent labs for tests. Would a vendor be allowed to staff a collector at each of the above mentioned clinics and collect the samples in house rather than the clinic sending its consumer out into the community? On site collection would facilitate timely and seamless reporting as well as ease the burden on providers and consumers.

 The applicant's proposal should clearly identify how they propose the services are to be delivered.
- 18) If on site collection is not an option, is there a current system in place for a vendor to know the names, locations and contact information for those independent labs?
 DPC needs are only for onsite testing. It is the intent of this RFP to consolidate the lab services required in the DSAMH funded community programs to utilize the awarded vendor and not have multiple independent labs.
