9. On page 5 of the RFP, there is a sentence that says "organizations that are currently funded by the Ryan White Part B/ADAP Program are excluded from submitting a bid application for this service." Does this exclusion apply only to organizations receiving money from DELAWARE's Program, or does it apply to organizations receiving those funds from ANY Part B/ADAP Program? Is it possible for organizations from other states to respond to this RFP?

Answer: Organizations receiving Delaware Part B/ADAP funds are not eligible to apply. An organization that receives Part B/ADAP funds from another state can apply.

10. What service categories are being monitored?

Answer: Per HRSA and state program guidelines.

11. Require a nurse to perform outpatient ambulatory guidelines chart reviews?

Answer: Not at this time.

12. Total number of program service providers?

Answer: The program has approximately 50 service providers.

13. What year will the selected contractor start chart reviews?

Answer: Fiscal year 2016, April 1, 2016 to March 31, 2017.
