### Update to Appendix B and Future Bid Submission Deadline

#### Language update to Appendix B

RFP HSS-20-040, Appendix B, pg. 51, par 1:

Current language:

“The RFP includes several housing types as described below. Any provider that proposes to house **eight (8)** or more individuals in a house setting must also comply with Title 29 Minimum Standards for Congregate living.”

Updated language:

“The RFP includes several housing types as described below. Any provider that proposes to house **five (5)** or more individuals in a house setting must also comply with Title 29 Minimum Standards for Congregate living.”

RFP HSS-20-040, Appendix B, pg. 91, #18:

Current language:

“18. Ensure that all residents have a PROMISE Care Manager and a primary clinical treatment provider unless the Group Home provider has elected to provide clinical supports. **Residents will also have an ICM or ACT team available 24 hours per day for psychiatric support.** Other supports may be identified in an individual’s PROMISE Recovery Plan or by a clinical treatment provider. The full array of PROMISE menu services and all community services that are applicable may apply.”
