The Division of Parks and Recreation, DNREC, will be receiving Supplemental Prequalification applications for **DNREC Contract No. 2018-FD-100** in the Office of Preservation, Planning and Development, Division of Parks and Recreation, DNREC, Richardson and Rollins Building, 89 Kings Highway, Dover, DE 19901 until **2:00 PM on Friday, January 4, 2019**. This project is anticipated to be advertised for bids in December 2018.

Office of Management and Budget, Division of Facilities Management (OMB/DFM) Annual Prequalification is a prerequisite to submitting the Supplemental Prequalification. Applications for Annual Prequalification can be submitted to OMB/DFM concurrently when the Supplemental Prequalification is submitted to the Division of Parks and Recreation.

Project Scope:

DNREC, Division of Parks and Recreation, Delaware State Parks is planning the following improvements at Pea Patch Island:

- Widening and improving the existing tramway from the pier to the Fort.
- The existing trails on the Island will be improved.
- A pre-purchased 30x60 pavilion is to be shipped to the Island and erected.
- Demolition of existing heronry viewing platform.and construction of new heronry viewing platform.
- Transporting owner purchased materials and vehicles to and from the Island. Allow for ten (10) trips. These trips are to include loading and unloading of the barge.
- Mobilization is anticipated to start September 2019.

To prequalify as a contractor/subcontractor for this project, contractor must be able to show three (3) similar size trail projects and two (2) water access projects. The contractor must be able to certify that personnel /project managers of these projects are still with the company. The State is looking for experience with this specific type work. The successful bid contractor must provide water access via barge and passenger boat.
