1	Q: Bid Form states "Should I/We be awarded this contract, I/We pledge to achieve substantial completion of all of the work associated with the new poll slides to have the new pool slides fully operational, inspected, and read to open to the public by May 27, 2016." We assume that the Purchase Order and contract Admin will require 60 days to complete from the receipt of bids. Submittals will require 4-6 weeks after NTP. Submittal approval 2 weeks after submission. with fabrication taking 8-12 weeks for some of the items. Secondly the project will be coming out of the ground during the months of Jan and February which will, as experience dictates, cause delays due to winter weather conditions. The project deadline does not allow ample time for completion of the project by May 27, 2016. Is there flexibility with finish date? Will the owner pay the additional costs for winter weather protection, winter concrete, winter masonry, tenting, temp heat etc in order to keep the project on schedule during the winter? Pecora Deck 800 in NOT an approved pool deck coating system.</li> </ul>

2	Q: Sheet 101C calls for the wall between the freezer/cooler to be 6" CMU. However sheet A101C calls for the wall to be a 8" CMU wall. Please clarify which is correct. A: Wall to be 8" CMU, to accommodate piping in the wall.
3	Q: Does the dumpster enclosure require any vertical reinforcement & grout? A: Provide solid grouted CMU core with No. 5 Rebar (vert) @ 48" o. c
4	Q: Is the dumpster enclosure included in the base bid because it is not shown on sheet C201. A: The dumpster enclosure is part of Alternate No.4, not Base Bid.
5	<ul><li>Q: Does the existing concession stand or existing bathhouse have any cultured stone veneer on them? If so, how high is it?</li><li>A: No stone veneer on these buildings</li></ul>
6	<ul> <li>Q: Sheet AD101-C shows the demolition of work on the existing concession stand. However, there are no drawings that show the new floor plan or elevations that show the wall types. Please provide details.</li> <li>A: The demolition included to disconnect, cut and cap utilities at walls, floor, and ceiling. The only additional work is to fill the opening in the wall where the cooler is removed. See Addendum No. 3 for additional information.</li> <li>BW Electric RFI 1</li> </ul>
