Per the revised Bid Due Date, the last Day for Questions shall be November 24, 2017 (2:00 PM) any questions received after this time will not be addressed. Questions will be answered via Addendum. Phone calls will not be replied to.

Bonds: Bid bond is required and is required to be submitted with your bid. Bond forms were included in the bid package Performance and Payroll bonds will be required for the work. Bond forms were included in the bid package and will be required upon notice of award of the contract, along with a certificate of insurance.

Wages/Payroll: Prevailing wage and payroll reporting are applicable to this project. The project determination is Highway Construction.

BIDS DUE: Thursday, November 30, 2017 at 2:00 PM Local Time. Any bid received after the stated time will be returned unopened. Bids accepted by overnight mail, or in person at DNREC – Division of Parks and Recreation, 89 Kings Highway, Dover DE 19901.

Bids will be opened and read aloud in the auditorium.

Sub-Contractors: A completed list of sub-contractors shall be submitted with your Bid. Reminder to name only one subcontractor for each of the following trades (these are also listed in the project book):

- Paving
- Signage and Striping
- Concrete
- Electric & Power

<u>Unit Prices:</u> There are a total of 5 Items that Unit Prices are requested:

- Undercut Excavation
- Paving (Asphalt)
- Del. No. 2 Stone
- Del. No. 57 Stone
- Graded Aggregate Base Course (GABC)

On-Site Superintendent: The contractor shall designate a superintendent who shall be on site for the duration of the project.

Completion of Work:

- <u>Notice of Contract Award</u>: Within thirty (30) days of receipt and acceptance of qualified low bid.
- <u>Purchase Order Issuance</u>: The issuance of a State of Delaware purchase order is contingent upon the successful Contractor submitting bonds on State-approved forms, signed contracts and insurance certificates to the State of Delaware within 20 days of Notice of Award. A purchase order will be issued in approximately thirty days after these items have been submitted to the State of Delaware.
- <u>On-Site Mobilization</u>: Upon receipt of State of Delaware purchase order.

- <u>Substantial Completion</u>: The work shall be completed 12 weeks from on-site start of work.
- <u>Completion of Punch List</u>: 21 days from date of substantial completion.

Permits: SSWM permit is required for this project.

• Working in Waterways: No work will occur in the waterway without proper permits.

Shop Drawings: All shop drawings and Source of Supply documents will be submitted electronically to the project file sharing site. The awarded contractor shall be provided access to the site. The contractor will designate a point of contact for access. The project team will have 15 days to review and respond to all shop drawings and Source of Supply documents. Please consider this when making submissions and scheduling the work.

Successful Bidder will be expected to enter into a Standard A101-2007Agreement between Owner and Contractor.

SCOPE OF WORK:

Base Bid: Project involves construction of the boat trailer parking to accommodate the boat ramp users. The contractor must construct the proposed parking lot per approved plans and to regrade the existing swale for positive drainage.

Questions

1. What does Alternate 3, the milling and overlaying of existing parking consist of? *The milling and the overlaying of the existing parking lot consist of the paved area in front of the existing boat ramp and approximately 60-foot of the existing road.*
