Sealed bids for DNREC Division of Fish and Wildlife Contract No FW-1-15, will be received by the State of Delaware, Division of Fish and Wildlife, in the Auditorium at 89 Kings Highway, Dover, Delaware 19901 until **10:00 am** local time on **November 30, 2017**, at which time they will be publicly opened and read aloud in the Auditorium. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Each bid must be accompanied by a bid security equivalent to ten percent of the bid amount and all additive alternates. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner reserves the right to reject any or all bids and to waive any informalities therein. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.

A. SCHEDULE

- 1. The following is the required schedule for this work:

 - b. <u>Notice of Contract Award</u>: Within thirty (30) days of receipt and acceptance of qualified low bid.
 - c. <u>Purchase Order Issuance</u>: The issuance of a State of Delaware purchase order is contingent upon the successful Contractor submitting bonds on State-approved forms, signed contracts and insurance certificates to the State of Delaware within 20 days of Notice of Award. A purchase order will be issued in approximately thirty days after these items have been submitted to the State of Delaware.
 - d. <u>On-Site Mobilization</u>: Upon receipt of State of Delaware purchase order.
 - e. <u>Substantial Completion</u>: The work shall be completed 10 weeks/70 calendar days from on-site start of work.
 - f. Completion of Punch List: 21 days from date of substantial completion.
