

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC5511000020 – DelDOT Administration Building – North Atrium Conference Room Water Infiltration** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 3:00 p.m. local time on Thursday, September 13, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at the DelDOT Administration Building located in Dover, Delaware: interior improvements in the Farmington/Felton Conference Room and Bethany Conference Room, both accessed from the North Atrium space; minor remediation work due to water infiltration will be completed by others under separate State contract prior to fit-out. The scope of work includes exterior wall improvements (interior side) including existing floor, wall and select finish replacement to facilitate the work.

A **MANDATORY** Pre-Bid Meeting will be held on Wednesday, August 29, 2018, at 8:30 a.m. in the Bidders Room at the DelDOT Administration Building, 800 Bay Road, Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

Sealed bids shall be addressed to the Division of Facilities Management, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901. The successful bidder must post a performance bond and payment bond in a sum equal to 100 percent of the contract price upon execution of the contract. The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
