Please be specific about which services you have experience with and provide descriptions
- \* organizational structure (personnel) established for the project including sub-consultants and previous experience (frequency) working with them
- \* defined approach firm/team will implement
- \* knowledge of sites and project requirements
- \* geographical location of main or branch office that will be assigned the project (relative to National Guard/Reserve Center, 250 Airport Road, New Castle, DE, 19720)
- \* familiarity with public works (including work in the State of Delaware, the <u>Delaware Code</u> and other local requirements)
- \* fees received by the firm for State of Delaware public works projects in the last five years (include breakdown)
