

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC3501000023 - Holloway Campus – Kent/Sussex Buildings – Sussex Staff Area 1 Renovations**, will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in Room 011 of the Main Building Annex of the Herman Holloway Campus, 1901 North DuPont Highway, New Castle, DE 19720 until 2:00 p.m. local time on Wednesday, July 2, 2014, at which time they will be publicly opened and read aloud. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at the Kent/Sussex Buildings located at the Herman Holloway Campus located in New Castle, Delaware: renovation of approximately 600 s.f. staff area to include office area, communications room and staff data entry area. Construction includes installation of vinyl flooring, drywall, metal stud, interior windows, acoustical lay-in ceilings, countertops and recessed computer tables. Bathroom renovations include new partitions, toilet fixtures and similar finishes.
