Sealed bids for **OMB/DFM Contract No. MC3505000016 – Governor Bacon Health Center – New Primary Electrical Service**, will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in Room 011 of the Main Building Annex of the Herman Holloway Campus, 1901 N. DuPont Highway, New Castle, DE 19720 until 1:00 p.m. local time on Wednesday, July 6, 2011, at which time they will be publicly opened and read aloud. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves furnishing and installing approximately 2,000 feet of new underground 12 KV electrical service to the Governor Bacon Health Center located in Delaware City, Delaware.
