

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC1002000112 – Department of Agriculture Building – HVAC Replacement**, will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Wednesday, November 30, 2011, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at the Department of Agriculture Building located in Dover, Delaware: demolition of the existing ceiling-mounted air handling units, all associated ductwork, electrical and piping; installation of a new four-pipe rooftop air handling unit including all associated ductwork, water piping, electrical and control wiring.
