

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC1002000184 – Public Safety Building – Heat Pump Replacement** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 3:30 p.m. local time on Thursday, September 6, 2012, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at the Public Safety Building located in Dover, Delaware: replacing the existing heat pumps for the entire building with a new hybrid heat pump including replacing the condenser water piping and providing and installing new fresh air ductwork to each heat pump. Project also includes the replacement of the building controls for the mechanical system.

Attention is called to construction schedule as detailed in the Bid Documents.

A **MANDATORY** Pre-Bid Meeting will be held on Wednesday, August 22, 2012, at 10:00 a.m. at the DMV Building, 303 Public Safety Boulevard, Dover, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**
