- 6. Bidding Documents are available for a non-refundable cost of \$75 per set (check only) through BMG, BMG distributed sets purchased at the meeting. No "digital" documents will be distributed.
- 7. Bidding Documents are available for viewing at Becker Morgan Group, Delaware Contractors Association and Association of Builders and Contractor.
- 8. Addenda: The last Addendum will be issued not later than four (4) days prior to bid, due to weekend, will be issued not later than Mondays morning, January 23, 2017.

- 13. Bidders were reminded to include copies of the signed Employee Drug Testing Program Affidavit forms for the Bidder and each listed Subcontractor with their bid.
- 14. Bidders were reminded that the Employee Drug Testing forms in accordance with 4104 Regulations for Drug Testing of Contractor and Subcontractor will be required to be submitted in accordance with the Regulation.
- 15. Subcontractor List: BMG read the subcontractor list included in the Project Manual and asked if there were any desired changes, none were expressed.
- 16. Bidders were reminded that the project is a Prevailing Wage project and the certified wage rates are included in the Project Manual.
- 17. Bid Bond: Required value of 10% of the Bid.
- 18. Performance Bond and Payment Bond are required for the project.
- 19. Construction Contract to be AIA A101-2007 Standard Form of Agreement Between Owner and Contractor.
- 20. Security: Captain Short of the Delaware State Police (DSP) indicated that all employees/workers working on site will be required to have State and Federal background checks by the State Bureau of Identification (SBI) and will be required to wear a badge or sticker indicating compliance.
