Sealed bids for **OMB/DFM Contract No. MC1002000096 – J.P. Court 7/16 – Controls Upgrade**, will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, February 24, 2011, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following at J.P. Court 7/16 located in Dover, Delaware: modification of the existing DDC system throughout the building, installation of control valves on existing boilers, installation of VFDs, electronic gas and water meters.
