

## ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC1002000242 – Carvel State Office Building – 12<sup>th</sup> Floor Restroom Renovations** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 2:00 p.m. local time on Thursday, November 17, 2016, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

Project involves the following on the 12<sup>th</sup> Floor of the Carvel State Office Building located in Wilmington, Delaware: alterations to the men's and women's toilet rooms to provide accessibility; work includes demolition of the existing toilet rooms and adjoining lobby, construction of new partitions, installation of new finishes, new plumbing fixtures, toilet partitions and accessories, new lighting, new exhaust system and other associated work. Adjacent office areas will be occupied throughout construction.

A **MANDATORY** Pre-Bid Meeting will be held on Wednesday, November 2, 2016, at 10:00 a.m. in the Facilities Management conference room on the first floor of the Carvel State Office Building, 820 N. French Street, Wilmington, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. **Contractors are to pass through security and gather in the lobby of the first floor.** Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**

The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
