

ADVERTISEMENT FOR BIDS

Sealed bids for **OMB/DFM Contract No. MC1002000270 – 900 King Street Facility – Attorney General’s Office – File Storage Room Renovations** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, in the reception area of the Facilities Management Office in the Thomas Collins Building, 540 S. DuPont Highway, Suite 1 (Third Floor), Dover, DE 19901 until 1:00 p.m. local time on Thursday, November 15, 2018, at which time they will be publicly opened and read aloud in the Conference Room. Bidder bears the risk of late delivery. Any bids received after the stated time will be returned unopened.

The project involves the following at the 900 King Street Facility in Wilmington, Delaware: removal of existing walls, ceilings, lighting and floor finishes at the basement storage area; installing new walls where shown, flooring and painting selected rooms; installing new staff transaction area counter and casework; installing new static storage shelving as well as High Density Electrically Operated Shelving Systems; installing new electrical and technology devices and outlets in existing and new walls; removal of existing light fixtures and installing new; reconfiguring extending existing ductwork and sprinkler heads and replacing selected HVAC equipment in existing spaces.

A **MANDATORY** Pre-Bid Meeting will be held on Wednesday, October 31, 2018, at 1:00 p.m. in the main front office of the 900 King Street Building, Wilmington, Delaware, for the purpose of establishing the list of subcontractors and to answer questions. Representatives of each party to any Joint Venture must attend this meeting. **ATTENDANCE OF THIS MEETING IS A PREREQUISITE FOR BIDDING ON THIS CONTRACT.**
